ORDER IN COUNCIL

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 9 of the Tariff Act 1988, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

1. Title and commencement—(1) This order may be cited as the Tariff (Tobacco Products Indexation) Amendment Order 1990.

(2) This order shall come into force on the 1st day of March 1990.

2. Tariff amended—The Tariff is hereby amended by revoking so much of Part I as relates to Tariff items 2402.10.00, 2402.20.02, 2402.20.08, 2402.90.01, 2402.90.12, 2402.90.18, 2403.10.09, 2403.91.09, 2403.99.01, and 2403.99.19, and substituting the Tariff items, rates of duty, and statistical keys specified in the Schedule to this order.

3. Consequential revocations—The Tariff (Miscellaneous) Amendment Order (No. 3) 1989 (S.R. 1989/250) is hereby amended by revoking so much of the Schedule as relates to Tariff items 2402.10.00, 2402.20.02, 2402.20.08, 2402.90.01, 2402.90.12, 2402.90.18, 2403.10.09, 2403.91.09, 2403.99.01, and 2403.99.19.

EXPLANATORY NOTE

This note is not part of the order, but is intended to indicate its general effect.

This order, which comes into effect on 1 March 1990, changes the Tariff in conjunction with changes made to the Excise Duties which have been adjusted according to the Consumer Price Index movement over the previous 2 quarters (excluding the impact of the increase in Goods and Services Tax which was effective on 1 July 1989).
