ORDER IN COUNCIL

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL PURSUANT to section 9 of the Tariff Act 1988, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

- 1. Title and commencement—(1) This order may be cited as the Tariff (Tobacco Products Indexation) Amendment Order (No. 2) 1990.
 - (2) This order shall come into force on the 1st day of September 1990.
- 2. Tariff amended—The Tariff is hereby amended by revoking so much of Part I as relates to Tariff items 2402.10.00, 2402.20.02, 2402.20.08, 2402.90.01, 2402.90.12, 2402.90.18, 2403.10.09, 2403.91.09, 2403.99.01, and 2403.99.19, and substituting the Tariff items, rates of duty, and statistical keys specified in the Schedule to this order.
- **3.** Consequential revocations—The Tariff (Miscellaneous) Amendment Order (No. 2) 1990 (S.R. 1990/124) is hereby amended by revoking so much of the Schedule to that order as relates to Tariff items 2402.10.00, 2402.20.02, 2402.20.08, 2402.90.01, 2402.90.12, 2402.90.18, 2403.10.09, 2403.91.09, 2403.99.01, and 2403.99.19.

EXPLANATORY NOTE

This note is not part of the order, but is intended to indicate its general effect.

This order, which comes into effect on 1 September 1990, changes the Tariff in conjunction with changes made to the excise duties on tobacco products which have been adjusted according to the Consumer Price Index based on its movement over the previous two quarters.
