**ORDER IN COUNCIL**

PURSUANT to section 9 of the Tariff Act 1988, Her Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

**ORDER**

**1. Title and commencement**—(1) This order may be cited as the Tariff (Tobacco Products Indexation) Amendment Order (No. 2) 1992.

(2) This order shall come into force on the 1st day of December 1992.

**2. Tariff amended**—The Tariff is hereby amended by revoking so much of Part I as relates to Tariff items 2402.10.00, 2402.20.02, 2402.20.08, 2402.90.01, 2402.90.12, 2402.90.18, 2403.10.09, 2403.91.09, 2403.99.01, and 2403.99.19, and substituting the Tariff items, rates of duty, and statistical keys specified in the Schedule to this order.

**3. Consequential revocation**—The Tariff (Tobacco Products Indexation) Amendment Order 1992 (S.R. 1992/84) is hereby revoked.

This order, which comes into force on 1 December 1992, changes duty rates in the Tariff in conjunction with changes made to the excise duties on tobacco products which have been adjusted according to the movement in the Consumers Price Index over the two quarters ending 30 June 1992 and 30 September 1992.
