## ORDER IN COUNCIL

#### Present:

HER EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

PURSUANT to section 9 of the Tariff Act 1988, Her Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

### ORDER

- 1. Title and commencement—(1) This order may be cited as the Tariff (Tobacco Products Indexation) Amendment Order (No. 2) 1994.
  - (2) This order shall come into force on the 1st day of December 1994.
- 2. Third Schedule—The Tariff is hereby amended by revoking so much of Part I as relates to Tariff items 2402.10.00, 2402.20.02, 2402.20.08, 2403.10.09, 2403.91.09, 2403.99.01, and 2403.99.29, and substituting the items, rates of duty, and statistical keys specified in the Schedule to this order.
- **3. Consequential revocations**—(1) The Tariff (Tobacco Products Indexation) Amendment Order 1994 (S.R. 1994/71) is hereby revoked.
- (2) The Tariff (Tobacco Substitutes) Amendment Order (No. 2) 1994 (S.R. 1994/246) is hereby amended by revoking so much of the Schedule as relates to Tariff item 2403.99.29.



## **EXPLANATORY NOTE**

This note is not part of the Order, but is intended to indicate its general effect.

This order, which comes into force on 1 December 1994, changes duty rates in the Tariff in conjunction with changes made to the excise duties on tobacco products (which duties have been adjusted according to the movement in the Consumers Price Index over the 2 quarters ending 31 March 1994 and 30 June 1994).

Issued under the authority of the Acts and Regulations Publication Act 1989. Date of notification in *Gazette*: 3 November 1994. This order is administered in New Zealand Customs.
