THE TIMBER PRESERVATION REGULATIONS 1984, AMENDMENT NO. 1

ORDER IN COUNCIL

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 71A of the Forests Act 1949, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Timber Preservation Regulations 1984, Amendment No. 1, and shall be read together with and deemed part of the Timber Preservation Regulations 1984* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 1st day of September 1987.

2. New regulations inserted in relation to charges—The principal regulations are hereby amended by inserting, after regulation 13, the following regulations:

"13A. Charges—(1) There shall be paid to the Authority in respect of each plant, whether registered before, on, or after the date of commencement of this regulation, in respect of the items specified in clauses 1 and 4 of the first column of the Second Schedule to these regulations, the charge specified opposite that item in the second column of that Schedule.

"(2) There shall be paid to the Authority, on demand, in respect of the items specified in clauses 2 and 3 of the first column of the Second Schedule to these regulations, the charge specified opposite that item in the second column of that Schedule.

"(3) The charge prescribed in clause 1 of the Second Schedule to these regulations shall be paid by each plant on application for registration pursuant to regulation 8 of the principal regulations or, in the case of each plant registered prior to the day on which these regulations come into force, within one month of the date of the commencement of this regulation.

"(4) The charges prescribed in clause 4 of the Second Schedule to these regulations shall be paid by each plant to the Authority on demand.

"(5) In every case where the timber treated by any plant fails to meet the standard specified in the Authority specifications and additional inspection testing and analysis of timber treated by any plant is required by the Authority the charges specified in clauses 5 and 6 of the Second Schedule to these regulations shall on demand be paid to the Authority by that plant.

"(6) Any charges unpaid shall constitute a debt due to the Authority and be recoverable by the Authority accordingly.

"13B. Amount of goods and services tax excluded—It is hereby declared that the charges set out in the Second Schedule to these regulations are exclusive of goods and services tax imposed under the Goods and Services Tax Act 1985."

3. Second Schedule—The principal regulations are hereby amended by adding the Second Schedule set out in the Schedule to these regulations.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations prescribe charges for Timber Preservation Authority specifications, registration of preservative timber treatment plants, and inspection, testing, and analysis of timber treated by plants. Goods and Services Tax of 10 percent is payable in addition to the charges.

Issued under the authority of the Regulations Act 1936. Date of notification in *Gazette:* 27 August 1987. These regulations are administered in the Ministry of Forestry.
