THE TROUT-FISHING (WELLINGTON) REGULATIONS 1936, AMENDMENT NO. 3.

GALWAY, Governor-General. ORDER IN COUNCIL.

At the Government House at Wellington, this 20th day of September, 1939.

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

Pursuant to the Fisheries Act, 1908, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

REGULATIONS.

- 1. These regulations may be cited as the Trout-fishing (Wellington) Regulations 1936, Amendment No. 3.
- 2. These regulations shall be read together with and form part of the Trout-fishing (Wellington) Regulations 1936* (hereinafter referred to as the principal regulations), and the amendments thereof.
- 3. These regulations shall come into force on the 1st day of October, 1939.
- **4.** Clause (b) of Regulation 6 of the principal regulations is further amended by revoking items (4), (16), (18), and (21) thereof, and substituting the following items:—
 - "(4) The Ohau River below the end of the Soldier's Road.
 - "(16) The Waiohine River below the main road bridge.
 - "(18) The Waingawa River below the main road bridge.
 - "(21) The Waiwhetu Stream below the Wainui-o-mata Road Bridge."
- 5. Regulation 7 of the principal regulations is amended by revoking the word "source", and substituting the words "junction with the Akatarawa River".
- 6. Regulation 9 of the principal regulations is amended by inserting after the word "worm", the words "or any kind of natural".

- 7. (a) Regulation 11 of the principal regulations is amended by revoking the figures "10", and substituting the figures "11".
- (b) The proviso to Regulation 11 of the principal regulations is amended by revoking the words "Kaiwarra Stream and the Korokoro Stream", and substituting the words "Kaiwarra Stream, South Karori Stream, and Korokoro Stream".
- 8. Regulation 12 of the principal regulations is revoked, and the following regulation substituted :— $\,$
- "12. Every person taking elsewhere than in the Kaiwarra Stream, South Karori Stream, or the Korokoro Stream a trout which does not exceed 11 in. in length from tip of nose to tip of tail shall immediately return it alive with as little injury as possible into the water from which it was taken."
- 9. Notwithstanding the provisions of Regulation 42 of the Freshwater Fisheries Regulations 1936, as amended by Regulation 6 of the Fresh-water Fisheries Regulations Amendment No. 2 and Regulation 53 of the Fresh-water Fisheries Regulations 1936, no person shall use a gaff for taking or killing trout or other acclimatized fish in the waters of the said district.
