**THE TROUT-FISHING (WELLINGTON) REGULATIONS 1936,
AMENDMENT NO. 4.**

GALWAY, Governor-General.

ORDER IN COUNCIL.

At the Government House at Wellington, this 7th day of
August, 1940.

Present :

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

PURSUANT to the Fisheries Act, 1908, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

REGULATIONS.

1. These regulations may be cited as the Trout-fishing (Wellington) Regulations 1936, Amendment No. 4.

2. These regulations shall be read together with and form part of the Trout-fishing (Wellington) Regulations 1936* (hereinafter referred to as the principal regulations) and the amendments thereof.

3. These regulations shall come into force on the 1st day of October, 1940.

4. (i) Regulation 6 of the principal regulations,
(ii) Regulations 6 and 7 of the Trout-fishing (Wellington) Regulations 1936, Amendment No. 1,
(iii) The Trout-fishing (Wellington) Regulations 1936, Amendment No. 2,
(iv) Regulation 4 of the Trout-fishing (Wellington) Regulations 1936, Amendment No. 3,

are revoked, and the following regulation substituted :—

“ 6. (a) No person shall fish for trout, perch, tench, or other acclimatized fish with any live or natural lure or bait in any waters in the said district except the waters named in clause (b) of this regulation.

5. Regulation 7 of the principal regulations and Regulation 5 of the Trout-fishing (Wellington) Regulations 1936, Amendment No. 3, are revoked, and the following regulation substituted:—

“ 7. No person shall fish for trout, perch, tench, or other acclimatized fish with any lure or bait other than artificial baits or bully in the Hutt River from Belmont Stream to its junction with the Akatarawa River.”

6. No person shall fish for trout, perch, tench, or other acclimatized fish with any lure or bait other than artificial lures or bait in that portion of the Oroua River between Menzies Ford Bridge and the Aorangi Bridge.

7. Regulation 8 of the principal regulations is revoked, and the following regulation substituted:—

“ 8. (a) No person shall fish for trout, perch, tench, or other acclimatized fish with any lure or bait other than artificial fly in the waters named in clause (b) of this regulation.

8. Regulation 13 of the principal regulations is revoked, and the following regulation substituted :—

“ 13. Any person committing a breach of these regulations shall be liable to a fine not exceeding £50.”
