**THE TROUT-FISHING (WAIMARINO) REGULATIONS 1937.**

Enacting authority : His Excellency the Governor-General in Council.  
Act pursuant to which the regulations were made : The Fisheries  
Act, 1908.

Date on which the regulations were made : 20th day of October, 1937.

Date of notification in *Gazette* : 28th day of October, 1937.

## REGULATIONS.

## PRELIMINARY.

1. These regulations may be cited as the Trout-fishing (Waimarino) Regulations 1937.

2. Terms used herein shall have the same meaning as in the Fresh-water Fisheries Regulations 1936\* hereinafter called "the General Regulations".

3. The trout-fishing regulations for the Waimarino Acclimatization District (hereinafter called "the said district") referred to in the Schedule hereto are revoked.

## DISTRICT AND LOCAL RESTRICTIONS.

4. No person shall fish for acclimatized fish within the said district with any lure or bait other than natural or artificial fly or other insect, natural or artificial fish (including spoon and minnow or worm).

5. No person shall use any lure or bait other than an artificial lure or bait in fishing for any acclimatized fish in any of the following waters, namely :—

- (1) The Piopotea Stream.
- (2) The Whakapapa Stream and its tributaries.
- (3) The Wanganui River from its source to a point five miles below the Matapuna Bridge.

6. No person shall intentionally fish for, take, or kill in any manner whatever or have in his possession any rainbow trout (*salmo irideus*) which—

- (a) If taken in or from the Mangawhero Stream or the Wanganui River is less than twelve inches in length from tip of nose to tip of tail :
- (b) If taken in or from any other waters in the said district is less than ten inches in length from tip of nose to tip of tail.

7. Every person taking an undersized rainbow trout as described in the last preceding regulation shall immediately return it alive with as little injury as possible into the water from which it was taken.

8. (a) Regulation 47 of the principal regulations shall not apply to the said district, but the proviso to the said Regulation 47 shall apply, *mutatis mutandis*, to this regulation.

(b) No person shall on any one day in the said district take or kill more than forty trout or more than thirty pounds weight of trout, and no person shall continue to fish for trout on any day on which he has already taken or killed forty trout or more than thirty pounds weight of trout.

(c) No person shall on any one day take or kill more than fifteen trout in the Wanganui River, and no person shall continue to fish for trout in the Wanganui River on any day on which he has already taken or killed fifteen trout in the Wanganui River.

PENALTY.

9. Any person committing a breach of these regulations shall be liable to a fine not exceeding fifty pounds (£50).
