THE TROUT-FISHING (WAITAKI) REGULATIONS 1937, AMENDMENT NO. 1.

ORDER IN COUNCIL.

At the Government House at Wellington, this 21st day of September, 1938.

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

PURSUANT to the Fisheries Act, 1908, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

REGULATIONS.

1. These regulations may be cited as the Trout-fishing (Waitaki) Regulations 1937, Amendment No. 1.

2. These regulations shall be read together with and form part of the Trout-fishing (Waitaki) Regulations 1937* (hereinafter referred to as the principal regulations).

3. These regulations shall come into force on the 1st day of October, 1938.

4. Paragraph (a) of Regulation 6 of the principal regulations is amended by adding the following proviso thereto:—

"Provided further that no person shall fish for trout or other acclimatized fish in the Ahuriri River, the Omarama Creek, and the other tributaries of the Ahuriri River with any bait or lure other than artificial bait."

5. Paragraph (c) of Regulation 8 of the principal regulations is amended by revoking all words after the words "The Waitaki Hydro Dam".

6. Regulation 8 of the principal regulations is further amended by adding the following paragraphs thereto :---

"(d) No person shall fish in the rivers or waters (being rivers or waters within the said district) mentioned in the succeeding clause (f) of this Regulation 8 for any trout which does not exceed 15 in. from tip of nose to tip of tail, and no person shall intentionally take or kill any such trout in any manner whatever or intentionally have in his possession any such trout taken from such river or waters:

- "(e) Every person taking from the rivers and waters mentioned in the succeeding clause (f) of this Regulation 8 any trout which does not exceed 15 in. in length from tip of nose to tip of tail shall immediately return it alive with as little damage or hurt as possible into the waters from which it was taken :
- "(f) The rivers and waters referred to in the last two preceding clauses hereof are the following, namely :----

"The Ahuriri River :

- "The Omarama Creek and other tributaries of the Ahuriri River:
- "The Ohau River:
- "Lake Ohau."
