## THE TROUT-FISHING (WAIMATE) REGULATIONS 1937, **AMENDMENT NO. 3**

#### HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Fisheries Act, 1908, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

### REGULATIONS

1. These regulations may be cited as the Trout-fishing (Waimate) Regulations 1937, Amendment No. 3.

2. These regulations shall be read together with and form part of the Trout-fishing (Waimate) Regulations 1937\* (hereinafter referred to as the principal regulations).

3. These regulations shall come into force on the 1st day of October, 1943.

4. Regulation 5 of the principal regulations is amended by revoking the words " subject as hereinafter appears ".

5. Paragraph (b) of Regulation 7 of the principal regulations is amended by deleting the words "twelve inches", and substituting the words "fourteen inches".

6. Paragraph (d) of Regulation 7 of the principal regulations is amended by deleting the words "twelve inches", and substituting the words "fourteen inches".

7. Regulation 9 of the principal regulations, as substituted by Regulation 4 of the Trout-fishing (Waimate) Regulations 1937, Amendment No. 1, is revoked.

8. The principal regulations are amended by inserting therein, next after Regulation 8 thereof and before the heading "Local **Restrictions** ", the following additional regulation :--

"9. (a) Notwithstanding the provisions of Regulation 8 hereof, no person shall on any one day take or kill in that part of the Waitaki River within the district more than fifteen trout or more than 20 lb.

weight of trout, and no person shall continue to fish for trout on any day on which he has already taken or killed fifteen trout or more than 20 lb. weight of trout :

"Provided, first, that the weight-limit of 20 lb. shall not apply until such person has taken or killed not less than six fish in any one day:

"Provided, secondly, that the quantities hereby specified shall be exclusive of any fish taken and dealt with pursuant to Regulations 49 and 50 of the General Regulations 1936:

"Provided, thirdly, that this regulation shall not apply to the fishing for, taking, or killing of trout in the course of an angling competition duly authorized by an acclimatization society.

 $(\tilde{}(b)$  Regulation 47 of the General Regulations shall not apply within the district."

9. The Trout-fishing (Waimate) Regulations 1937, Amendment No. 1, are revoked.
