# THE TOHEROA REGULATIONS 1955, AMENDMENT NO. 17

## ORDER IN COUNCIL

At the Government House at Wellington this 28th day of August 1978

#### Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Fisheries Act 1908, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

## REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Toheroa Regulations 1955, Amendment No. 17, and shall be read together with and deemed part of the Toheroa Regulations 1955\* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 16th day of September 1978.

2. Open season for the taking of toheroa--(1) Notwithstanding anything in the definition of the term "close season" in regulation 2 (1) of the principal regulations (as substituted by regulation 2 (1) of the Toheroa Regulations 1955, Amendment No. 13) there shall be an open season for the taking of toheroa-

(a) For the period commencing on the 16th day of September 1978 and ending with the 22nd day of September 1978 in the North Island on-

(i) That part of Dargaville Beach located between North Head and Maunganui Bluff:

(ii) Foxton Beach, located between the Manawatu River and the Rangitikei River:

(iii) Waitarere North Beach, located between the southern end of the Waitarere surf club building and the Manawatu River:

(iv) Otaki Beach, located between the Otaki River and the Ohau River:

(b) For the period commencing on the 23rd day of September 1978 and ending with the 29th day of September 1978 in the South Island on—

(i) Oreti Beach, excluding that portion of Oreti beach lying between New River and a point 1 km south of the southern beach entrance:

(ii) Te Waewae Bay.

(2) Regulation 3 of the Toheroa Regulations 1955, Amendment No. 16, is hereby consequentially revoked.

#### EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations provide for an open season for the taking of toheroa from Dargaville Beach, Foxton Beach, Waitarere North Beach, and Otaki Beach in the North Island, and Te Waewae Bay and most of Oreti Beach in the South Island, during the periods specified in the regulations.
