



THE TOHEROA REGULATIONS 1955, AMENDMENT NO. 18

ORDER IN COUNCIL

At the Government House at Wellington this 20th day of August 1979

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Fisheries Act 1908, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Toheroa Regulations 1955, Amendment No. 18, and shall be read together with and deemed part of the Toheroa Regulations 1955* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 15th day of September 1979.

2. Open season for taking toheroa—Notwithstanding the definition of the term “close season” in regulation 2 (1) of the principal regulations (as substituted by regulation 2 (1) of the Toheroa Regulations 1955, Amendment No. 13, and amended by regulation 2 (2) of the Toheroa Regulations 1955, Amendment No. 16) there shall be an open season for the taking of toheroa for the period commencing on the 15th day of September 1979 and ending with the 21st day of September 1979 on—

- (a) Dargaville Beach, between North Head and Maunganui Bluff;
- (b) Waitarere Beach and Hokio Beach, between a line extended seawards from the Beach Road ramp at Waitarere and the Ohau River;
- (c) Te Horo Beach and Peka Peka Beach, between the Te Horo Stream and the Waikanae River.

3. Increase in minimum size—Regulation 4 of the principal regulations (as amended by regulation 5 (1) of the Toheroa Regulations 1955, Amendment No. 14) is hereby amended by omitting the expression “75 mm”, and substituting the expression “100 mm”.

4. Revocations—The following regulations are hereby consequentially revoked:

- (a) Regulation 5 (1) of the Toheroa Regulations 1955, Amendment No. 14:
- (b) The Toheroa Regulations 1955, Amendment No. 17.

EXPLANATORY NOTE

This note is not part of the regulations, but it is intended to indicate their general effect.

These regulations provide for an open season for the taking of toheroa from the beaches specified in regulation 2. The minimum size of toheroa that may be taken has been increased from 75 mm to 100 mm in greatest length.
