THE TRAFFIC REGULATIONS 1956, AMENDMENT NO. 20

ORDER IN COUNCIL

At the Government Buildings at Wellington this 14th day of December 1970

PURSUANT to the Transport Act 1962, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Traffic Regulations 1956, Amendment No. 20, and shall be read together with and deemed part of the Traffic Regulations 1956* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 1st day of February 1971.

2. Keeping to left of road—Regulation 6 of the principal regulations is hereby amended by revoking subclause (3).

3. Overtaking at places where "No-overtaking" lines marked— Regulation 8 of the principal regulations (as substituted by regulation 3 (1) of the Traffic Regulations 1956, Amendment No. 15) is hereby amended by revoking subclause (2).

4. Overtaking at other places—Regulation 9 of the principal regulations is hereby amended by revoking subclause (2).

5. Temporary speed limits—Regulation 31 of the principal regulations is hereby amended by revoking subclause (4).

6. Penalties—The principal regulations are hereby further amended by revoking regulation 132, and substituting the following regulation:

"132. (1) Every person who commits a breach of Part VII of these regulations is liable to a fine not exceeding \$10.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations remove the penalty provisions from the principal regulations except the penalty of \$10 provided for a breach of Part VII (relating to pedestrians).

The general penalties for breaches of all regulations made under the Transport Act 1962 are now provided in section 30 (4) of that Act (as enacted by section 2 of the Transport Amendment Act 1970).
