ORDER IN COUNCIL

At the Government House at Wellington this 21st day of July 1975

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Transport Act 1962, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Traffic Regulations 1956, Amendment No. 30, and shall be read together with and deemed part of the Traffic Regulations 1956* (hereinafter referred to as the principal regulations).
- (2) These regulations shall come into force on the 4th day of August 1975.
- 2. Metric amendments—The principal regulations are hereby amended in the manner indicated in the First Schedule to these regulations.
- 3. Restrictions on stopping or parking vehicles—(1) Regulation 19 (2) (b) of the principal regulations (as substituted by regulation 8 (1) of the Traffic Regulations 1956, Amendment No. 15) is hereby amended—
 - (a) By omitting the words "less than 2 ft nor more than 4 ft", and substituting the words "more than 1 m":
 - (b) By omitting the expression "20 ft", and substituting the expression "6 m".

- (2) Regulation 19 (2) (e) of the principal regulations (as substituted by regulation 6 of the Traffic Regulations 1956, Amendment No. 23) is hereby amended—
 - (a) By omitting the words "20 feet", and substituting the expression "6 m":
 - (b) By omitting the words "less than 2 feet nor more than 4 feet", and substituting the words "more than 1 m".
- 4. Speed limits—(1) Regulation 26 of the principal regulations is hereby amended by revoking subclause (1) (as substituted by regulation 2 (1) of the Traffic Regulations 1956, Amendment No. 17), and substituting the following subclause:

"(1) No person shall on any road drive any motor vehicle at a speed

exceeding 80 kilometres an hour:

"Provided that it shall be a defence to any person charged with an offence against this subclause if he proves that he was at the time of the act in respect of which he is so charged the driver of a motor vehicle—

"(a) Used as an ambulance fitted with a siren or bell and being at

the time used on urgent ambulance service; or

"(b) Used for a fire brigade for attendance at fires and at the time responding to a call of fire; or

"(c) Conveying a traffic officer or police officer engaged on urgent

public business or in the execution of his duty; or

"(d) Conveying a member of the Executive Council engaged on urgent public business, or conveying any other person authorised in that behalf by the Minister and engaged on urgent public business in the execution of his functions."

(2) Regulations 27B and 27c of the principal regulations (as inserted by regulations 3 (1) and 4 of the Traffic Regulations 1956, Amendment

No. 17) are hereby revoked.

- 5. Passing school buses—Regulation 33 of the principal regulations (as amended by regulation 8 of the Traffic Regulations 1956, Amendment No. 23) is hereby amended—
 - (a) By omitting from subclause (1) the words "10 miles", and sub-

stituting the words "20 kilometres":

- (b) By omitting from subclause (2) the words "not less than 6 ft", and substituting the words "with its lower edge not less than 1.5 m".
- 6. Tyres—Regulation 44A of the principal regulations (as substituted by regulation 8 (1) of the Traffic Regulations 1956, Amendment No. 17) is hereby amended by revoking subclause (2), and substituting the following subclause:
- "(2) No person shall on any road use on any motor vehicle a pneumatic tyre having a tread pattern (excluding any tie-bar or tread-depth indicator strip) of less than—
 - "(a) 3 mm in depth, in the case of any passenger-service vehicle that weighs more than 2000 kg:
- "(b) 1.5 mm in depth, in the case of any other motor vehicle across at least three-quarters of the breadth of the tread and around the entire circumference of the tyre. Nothing in this subclause shall apply with respect to any motor vehicle which is not capable of a speed in excess of 30 kilometres an hour, nor to any trailer drawn by such a vehicle, nor to any trailer which has a gross weight less than 1000 kg, nor to any

power cycle, nor to any tyre on a twin wheel fitted to a vehicle that is not principally designed for the carriage of passengers unless both the tyres fitted to that twin wheel have a tread pattern less than that specified as aforesaid."

- 7. Classes of traffic signs—Regulation 120 (1) of the principal regulations is hereby amended—
 - (a) By revoking so much thereof as relates to signs of Class I (as substituted by regulation 3 (2) of the Traffic Regulations 1956, Amendment No. 17), and substituting the following words:

"Class I: Signs denoting—
"(a) The presence of a 50 kilometre speed-limit area;

or

"(b) The presence of a 70 kilometre speed-limit area;

"(c) A local speed-limit:":

(b) By revoking so much thereof as relates to signs of Class K (as substituted by regulation 3 (3) of the Traffic Regulations 1956, Amendment No. 17), and substituting the following words:

"Class K: Signs denoting the presence of an area where the

80 kilometre speed-limit applies:".

- 8. Description of traffic signs—Regulation 121 of the principal regulations is hereby amended by revoking subclause (18c) (as inserted by regulation 12 (5) of the Traffic Regulations 1956, Amendment No. 5), and substituting the following subclause:
- "(18c) Signs of Class N shall be in the form of and have the dimensions and colours shown in diagram No. 19 in the Fourth Schedule hereto."
- 9. Erection of traffic signs—Regulation 125 (13) of the principal regulations is hereby amended by revoking paragraphs (a) to (c) (as substituted by regulation 3 (4) of the Traffic Regulations 1956, Amendment No. 17), and substituting the following paragraphs:
 - "(a) An area which is lawfully subject to a speed limit of less than 80 kilometres an hour, signs of Class I:
 - "(b) An area which forms a limited speed zone, signs of Class J:
 - "(c) An area where the maximum speed limit is 80 kilometres an hour, signs of Class K."
- 10. Road markings—Regulation 129A of the principal regulations (as substituted by regulation 19 of the Traffic Regulations 1956, Amendment No. 23) is hereby amended by omitting the words "less than 2 ft nor more than 4 ft", and substituting the words "more than 1 m".
- 11. Pedestrian crossing markings—The Third Schedule to the principal regulations is hereby amended by omitting from diagram No. 1 (as substituted by regulation 4 of the Traffic Regulations 1956, Amendment No. 8) the words "Crossing to be set a minimum of 2 ft from corner of footpath".

12. Traffic signs—The Fourth Schedule to the principal regulations is hereby amended-

(a) By revoking diagram No. 14, and substituting the diagram set out

in the Second Schedule to these regulations:

- (b) By revoking diagram No. 19 (as added by regulation 12 (6) of the Traffic Regulations 1956, Amendment No. 5), and substituting the diagram set out in the Third Schedule to these regulations.
- 13. Consequential revocations and savings—(1) The following regulations are hereby consequentially revoked:
 - (a) Regulations 2, 3, and 4 of the Traffic Regulations 1956, Amendment No. 17:
 - (b) Regulation 2 (1) of the Traffic Regulations 1956, Amendment No.
 - (c) Regulation 2 of the Transport (Motor Spirits Conservation) Regulations 1973* and the Schedule to those regulations.
- (2) Every traffic sign erected pursuant to the principal regulations that indicated a speed limit expressed in miles an hour before the commencement of these regulations and that has not been modified to accord with diagram No. 14 of the Fourth Schedule to the principal regulations (as substituted by regulation 12 (a) of these regulations) shall, after the commencement of these regulations, have effect as if the sign had been so modified and indicated a speed limit of—
 - (a) In the case of a sign that indicated a speed limit of 20 miles an

hour, 30 kilometres an hour:

- (b) In the case of a sign that indicated a speed limit of 30 miles an hour, 50 kilometres an hour:
- (c) In the case of a sign that indicated a speed limit of 40 miles an hour, 70 kilometres an hour:
- (d) In the case of a sign that indicated a speed limit of 50 miles an hour, 80 kilometres an hour:
- (e) In any other case, 1.6 kilometres an hour for every mile an hour indicated by the sign.
- (3) Where a notice in the Gazette made pursuant to the principal regulations contains a measurement expressed in Imperial units and the same measurement in the principal regulations has been amended by these regulations to a measurement expressed in metric units, that notice shall, from the commencement of these regulations, have effect as if the measurement contained in that notice was the aforesaid measurement expressed in metric units.



"CLASS I Diagram No. 14





EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations amend the Traffic Regulations 1956 (the principal regulations).

Regulation 2 substitutes, for the various measurements specified in the principal regulations (other than the dimensions of traffic signs and markings), their approxi-

regulations (other than the dimensions of traine signs and other minor amendments to regulations 3, 5, 10, and 11 make metric conversions and other minor amendments to regulations 19 (restrictions on stopping or parking vehicles), 33 (passing school buses), 129a (road markings), and the Third Schedule diagram No. 1 (pedestrian crossing markings) respectively of the principal regulations.

Regulation 4 amends regulation 26 (speed—general provisions) of the principal

Regulation 4 amends regulation 26 (speed—general provisions) of the principal regulations to provide that the maximum speed limit is 80 kilometres an hour (equivalent to 50 miles an hour). Regulations 7 and 9 make consequential amendments to regulations 120 (classes of traffic signs) and 125 (erection of traffic signs) respectively of the principal regulations. (Note—Regulation 2 of the Transport (Motor Spirits Conservation) Regulations 1973 amended the principal regulations in the same way as regulations 4, 7, and 9 of these regulations—but on a temporary basis only. Regulation 2 of the Transport (Motor Spirits Conservation) Regulations 1973 is revoked by regulation 13 (1) of these regulations.)

Regulation 6 amends regulation 44 (tyres) of the principal regulations by substituting approximate metric equivalents for the various measurements specified in that regulation and by inserting a special minimum tyre tread-depth for

ned in that regulation and by inserting a special minimum tyre tread-depth for passenger-service vehicles that weigh more than 2000 kg (namely, 3 mm). Regulation 8 amends regulation 121 (description of traffic signs) of the principal regulations. This amendment is consequential on the amendment effected by regulation 12 (b) of these regulations. Regulation 12 amends the Fourth Schedule to the principal regulations by substituting a new diagram No. 14 (signs denoting speed limits) and a new diagram No. 19 (signs indicating speed which, owing to a bend, turning, or intersection in the road, a driver should not exceed).

Regulation 13 makes consequential revocations and savings
