THE TELEX REGULATIONS 1963, AMENDMENT NO. 7

ORDER IN COUNCIL

At the Government House at Wellington this 22nd day of May 1972

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

Pursuant to the Post Office Act 1959, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Telex Regulations 1963, Amendment No. 7, and shall be read together with and deemed part of the Telex Regulations 1963* (hereinafter referred to as the principal regulations).
- (2) These regulations shall come into force on the day after the date of their notification in the Gazette.
- 2. Teltex service—(1) Regulation 39B of the principal regulations (as inserted by regulation 4 of the Telex Regulations 1963, Amendment No. 5) is hereby amended by adding to paragraph (b) of subclause (2) (as amended by regulation 7 of the Telex Regulations 1963, Amendment No. 6) the following proviso:

"Provided that where, in special circumstances approved by the Director-General, this service is provided outside its normal hours as published from time to time, the service fee shall be twice this amount."

(2) The said regulation 39B is hereby further amended by adding the following subclauses:

"(4) The service provided by subclause (1) of this regulation shall apply to a telex message sent by an overseas telex subscriber with the following modifications:

"(a) In lieu of the charge prescribed by subclause (2) of this regulation, the charge payable for this service shall be the

total of—

"(i) The service fee as prescribed by paragraph (b) of the said subclause (2); and

"(ii) The collect charge as prescribed by paragraph (a) of subclause (3) of this regulation:

"(b) This charge shall be payable by the addressee."

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations provide for an after-hours Teltex service, supplementary Teltex services, and an inward international Teltex service.
