

# THE TELEPHONE REGULATIONS 1976, AMENDMENT NO. 11

#### ORDER IN COUNCIL

At the Government House at Wellington this 20th day of December 1982

### Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Post Office Act 1959, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

### REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Telephone Regulations 1976, Amendment No. 11, and shall be read together with and deemed part of the Telephone Regulations 1976\* (hereinafter referred to as the principal regulations).
- (2) These regulations shall come into force on the 1st day of January 1983.
- 2. First Schedule—(1) Part II of the First Schedule to the principal regulations (as substituted by regulation 2 of the Telephone Regulations 1976, Amendment No. 8, and amended by regulation 4 of the Telephone Regulations 1976, Amendment No. 9) is hereby amended by revoking clause 11, and substituting the new clause 11 set out in the First Schedule to these regulations.

### FIRST SCHEDULE

New clause 11 of Part II of the First Schedule to the principal regulations

"11. Non-standard telephones (Reg. 86)—(1) The following additional 2 monthly rentals are payable in respect of non-standard telephones:

- (2) The rental for the non-standard telephones specified in paragraphs (b) and (c) of subclause (1) of this clause when connected to an electronic P.A.B.X. shall be as specified in clause 10 (a) (1) (vi) of Part III of this Schedule.
- (3) Installation fees are covered by the prescribed charge for a new connection, new extension or change in type of telephone. Where the telephones specified in paragraphs (d), (e), and (f) of subclause (1) of this clause are installed on intercommunicating systems or leased circuits, labour and incidental costs are payable. Where special means or material are used to provide the telephones specified in paragraphs (d), (e), and (f), of subclause (1) of this clause the cost of labour, materials, and incidental expenses is payable.
- (4) In special circumstances, the Minister may waive or reduce the installation charges in respect of the telephones specified in paragraphs (b), (c), and (g) of subclause (1) of this clause."

### SECOND SCHEDULE

Reg. 2 (2)

New subparagraph (vi) of clause 10 (a) (1) of Part III of the First Schedule to the principal regulations

"(vi) In the case of 100 type push-button telephones connected on an electronic P.A.B.X. system, no rental additional to that specified in subparagraphs (i) and (iv) hereof shall be payable. A 2-monthly rental of \$2 in addition to that specified in subparagraphs (i) and (iv) hereof shall apply for each 200 type push-button telephone connected on an electronic P.A.B.X."

### **EXPLANATORY NOTE**

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations come into force on 1 January 1983 and prescribe charges for additions to the range of non-standard telephones.
