PURSUANT to section 199 of the Transport Act 1962, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Traffic Regulations 1976, Amendment No. 19, and shall be read together with and deemed part of the Traffic Regulations 1976* (hereinafter referred to as the principal regulations).
 - (2) These regulations shall come into force on the 1st day of July 1989.

- 2. Fees in relation to approved testing authorities—Regulation 84 of the principal regulations (as substituted by regulation 10 (1) of the Traffic Regulations 1976, Amendment No. 15 and amended by regulation 2 of the Traffic Regulations 1976, Amendment No. 16) is hereby amended by omitting from both subclause (4) and subclause (5) the expression "\$136", and substituting in each case the expression "\$139".
- **3. Fees in relation to authorised agencies**—(1) Regulation 90s of the principal regulations (as inserted by regulation 5 (1) of the Traffic Regulations 1976, Amendment No. 7) is hereby amended by omitting from both subclause (7) and subclause (8) (as added by regulation 11 of the Traffic Regulations 1976, Amendment No. 15 and amended by regulation 3 of the Traffic Regulations 1976, Amendment No. 16) the expression "\$136", and substituting in each case the expression "\$139".

(2) Regulation 90c of the principal regulations is hereby further amended by omitting from subclause (9) (as so added and amended) the

expression "\$204", and substituting the expression "\$209".

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations increase certain fees prescribed in the Traffic Regulations 1976 to reflect the increase in goods and services tax from 10 percent to 12.5 percent. The increases come into force on 1 July 1989.
