PURSUANT to the Post Office Act 1959, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Telex Regulations 1977, Amendment No. 1, and shall be read together with and deemed part of the Telex Regulations 1977* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 1st day of October 1979.

2. Service connection fee—Regulation 13 of the principal regulations is hereby amended by omitting the expression "\$100", and substituting the expression "\$133".

3. Call charges—Regulation 17 (1) of the principal regulations is hereby amended by omitting the words “7.5 cents for each 8 seconds’ duration”, and substituting the words “5.625 cents for each 6 seconds’ duration”.

4. Discontinuance of service of defaulting subscriber—Regulation 20 (4) of the principal regulations is hereby amended by omitting the expression “\$15”, and substituting the expression “\$20”.

5. Additional directory listings—Regulation 23 (1) of the principal regulations is hereby amended—

- (a) By omitting from paragraph (a) the expression “\$1”, and substituting the expression “\$1.20”;
- (b) By omitting from paragraph (b) the expression “63 cents”, and substituting the expression “75 cents”.

6. Public telex booths—Regulation 35 of the principal regulations is hereby amended—

- (a) By omitting from subclause (2) (b) the expression “60 cents”, and substituting the expression “\$1”;
- (b) By omitting from subclause (3) the expression “20 cents”, and substituting the expression “25 cents”.

7. Telex messages for delivery by the Post Office (Teltex)—Regulation 36 of the principal regulations is hereby amended—

- (a) By omitting from subclause (2) (b) the expression “90 cents”, and substituting the expression “\$1.60”;
- (b) By omitting from subclause (3) (a) the expression “20c”, and substituting the expression “25c”;
- (c) By omitting from subclause (3) (b) the expression “35c”, and substituting the expression “60c”.

8. Messages lodged by telephone for telex delivery by the Post Office (Phonatelex)—Regulation 37 of the principal regulations is hereby amended—

- (a) By omitting from subclause (3) (b) the expression “\$1.50”, and substituting the expression “\$2.50”;
- (b) By omitting from subclause (3) (b) the expression “50 cents”, and substituting the expression “85 cents”;
- (c) By omitting from subclause (4) the expression “20 cents”, and substituting the expression “25 cents”.

9. Removals—Regulation 38 of the principal regulations is hereby amended—

- (a) By omitting from subclause (1) (a) the figure “100”, and substituting the figure “133”;
- (b) By omitting from subclause (1) (a) the figure “20”, and substituting the figure “27”;
- (c) By omitting from subclause (1) (b) the figure “60”, and substituting the figure “80”.

10. Change of teleprinter—Regulation 39 (2) of the principal regulations is hereby amended by omitting the expression “\$100”, and substituting the expression “\$133”.

11. Change of answer-back code—Regulation 40 of the principal regulations is hereby amended by omitting the expression “\$20”, and substituting the expression “\$27”.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations increase certain charges for the telex service with effect from 1 October 1979.
