HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Post Office Act 1959, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Telegraph Regulations 1977, Amendment No. 1, and shall be read together with and deemed part of the Telegraph Regulations 1977* (hereinafter referred to as the principal regulations).
- (2) These regulations shall come into force on the 1st day of October 1979.

- 2. Ordinary telegrams—Regulation 3 of the principal regulations is hereby amended—
 - (a) By omitting from subclause (2) the expression "4c", and substituting the expression "6c":
 - (b) By omitting from subclause (2) the expression "50c", and substituting the expression "\$1":
 - (c) By omitting from subclause (3) the expression "8c", and substituting the expression "12c":
 - (d) By omitting from subclause (3) the expression "\$1", and substituting the expression "\$2".
- **3. Urgent telegrams**—Regulation 4 of the principal regulations is hereby amended by omitting the expression "35c", and substituting the expression "60c".
- **4. Letter telegrams**—Regulation 5 of the principal regulations is hereby amended—
 - (a) By omitting the expression "2c", and substituting the expression "3c":
 - (b) By omitting the expression "25c", and substituting the expression "50c".
- **5. Collect telegrams**—Regulation 6 of the principal regulations is hereby amended by omitting the expression "20c", and substituting the expression "25c".
- **6. Decorative stationery**—Regulation 7 of the principal regulations is hereby amended by omitting the expression "15c", and substituting the expression "30c".
- 7. Multiple telegrams—Regulation 8 of the principal regulations is hereby amended by omitting from paragraph (b) the expression "50c", and substituting the expression "85c".
- **8. Weather telegrams**—Regulation 9 of the principal regulations is hereby amended—
 - (a) By omitting from subclause (1) the figure "25", and substituting the figure "45":
 - (b) By omitting from subclause (1) the figure "50", and substituting the figure "90":
 - (c) By omitting from subclause (2) the expression "2c", and substituting the expression "3c":
 - (d) By omitting from subclause (2) the expression "4c", and substituting the expression "6c".
- **9. Cancellation of telegrams**—Regulation 12 of the principal regulations is hereby amended by omitting the expression "10c", in both places where it occurs, and substituting in each case the expression "17c".

- 10. Phototelegrams—Regulation 13 of the principal regulations is hereby amended—
 - (a) By omitting from subclause (1) the expression "\$12", and substituting the expression "\$20":
 - (b) By omitting from subclause (2) the expression "\$9.60", and substituting the expression "\$16".
- 11. Phototelegrams addressed to 2 or more addresses—Regulation 14 of the principal regulations is hereby amended by omitting from paragraph (b) the expression "\$2.40", and substituting the expression "\$5".
- 12. Additional copies—Regulation 15 of the principal regulations is hereby amended by omitting the expression "\$1.20", and substituting the expression "\$2.50".
- 13. Press telegrams—Regulation 16 (1) of the principal regulations is hereby amended—
 - (a) By omitting from paragraph (a) the expression "60c", and substituting the expression "\$1":
 - (b) By omitting from paragraph (b) the expression "75c", and substituting the expression "\$1.30".
- 14. Transferred charge telegrams—Regulation 18 of the principal regulations is hereby amended by omitting from subclause (3) the expression "20c", and substituting the expression "25c".
- 15. New regulations relating to carriage charges substituted— The principal regulations are hereby amended by revoking regulation 19, and substituting the following regulations:
- "19. Carriage charges during the ordinary rate period—
 (1) For the delivery of telegrams beyond the telegram delivery area, but within 5 kilometres of the office of destination when that office is open, the carriage charges shall be 60c a kilometre or part thereof for the distance beyond the telegram delivery area.
- "(2) For the delivery of telegrams beyond 5 kilometres of the office of destination when that office is open, the carriage charges payable shall equal the charges incurred in effecting delivery by special messenger.
- "19A. **Delivery fee during the after-hour period**—(1) For the delivery during the after-hour period within the delivery area of the office of destination of a telegram or an advice that a telegram is held at a Post Office, a fee of \$2 shall apply if a telephone address cannot be established at the time of lodgment.
- "(2) For the delivery during the after-hour period beyond the delivery area of the office of destination of a telegram or an advice that a telegram is held at a Post Office, actual delivery costs with a minimum of \$2 shall apply if a telephone address cannot be established at the time of lodgment.
- "(3) This regulation shall not apply to telegrams with respect to offices open on Saturdays until after 11.30 a.m. that day, and regulation 19 of these regulations shall apply instead thereof."

16. Redelivery of telegrams—Regulation 20 (a) of the principal regulations is hereby amended—

(a) By omitting the word "free":

- (b) By omitting the expression "30c", and substituting the expression "50c".
- 17. Reopening of office for ordinary telegrams—Regulation 21 of the principal regulations is hereby amended—

(a) By omitting from paragraph (a) (i) the expression "15c", and

- substituting the expression "30c":

 (b) By omitting from paragraph (a) (ii) the expression "35c", and substituting the expression "60c":
- (c) By omitting from paragraph (b) (i) the expression "50c", and substituting the expression "85c":
- (d) By omitting from paragraph (b) (ii) the expression "\$1", and substituting the expression "\$1.70":
- (e) By omitting from paragraph (b) (ii) the expression "50c", and substituting the expression "85c".
- 18. Reopening of office for press telegrams—Regulation 22 of the principal regulations is hereby amended by omitting the expression "\$7", and substituting the expression "\$12".
- 19. Code addresses—Regulation 24 of the principal regulations is hereby amended-

(a) By omitting from subclause (1) the figure "18", and substituting the figure "30":

(b) By omitting from subclause (1) the figure "4.50", and substituting the figure "7.50":

(c) By omitting from subclause (2) the figure "0.15", and substituting

the figure "0.30":
(d) By omitting from subclause (2) the figure "0.35", and substituting the figure "0.60".

20. Inspection of original telegram—Regulation 26 of the principal regulations is hereby amended-

(a) By omitting from paragraph (a) of subclause (2) the figure "0.60", and substituting the figure "1.00".

(b) By omitting from paragraphs (b) and (c) of subclause (2) the figure "1.20", and substituting in each case the figure "2.00".

- 21. Copy of telegram—Regulation 27 (1) of the principal regulations is hereby amended by omitting the expression "50c", and substituting the expression "85c".
- 22. Rental for lease of telegraph apparatus—The principal regulations are hereby amended by revoking the First Schedule, and substituting the new First Schedule set out in the Schedule attached to these regulations.

These regulations come into force on 1 October 1979 as set out in a new scale of charges

Regulation 15 provides for a fee to be charged for the delivery of telegrams during the after-hours period.
