### ORDER IN COUNCIL

PURSUANT to the Post Office Act 1959, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

#### REGULATIONS

**1. Title and commencement**—(1) These regulations may be cited as the Telegraph Regulations 1977, Amendment No. 6, and shall be read

together with and deemed part of the Telegraph Regulations 1977\* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 1st day of April 1986.

**2. Ordinary telegrams**—(1) Regulation 3 of the principal regulations (as amended by regulation 2 of the Telegraph Regulations 1977, Amendment No. 5) is hereby further amended—

(a) By omitting from subclause (2) the expression “15c”, and substituting the expression “20c”:

(b) By omitting from subclause (2) the expression “\$2.45”, and substituting the expression “\$3.60”:

(c) By omitting from subclause (3) the expression “30c”, and substituting the expression “45c”:

(d) By omitting from subclause (3) the expression “\$5.00”, and substituting the expression “\$7.50”.

(2) The Telegraph Regulations 1977, Amendment No. 5 are hereby consequentially amended by revoking regulation 2.

**3. Urgent telegrams**—(1) Regulation 4 of the principal regulations (as amended by regulation 3 of the Telegraph Regulations 1977, Amendment No. 5) is hereby further amended by omitting the expression “\$1.50”, and substituting the expression “\$2.25”.

(2) The Telegraph Regulations 1977, Amendment No. 5 are hereby consequentially amended by revoking regulation 3.

**4. Letter telegrams**—(1) Regulation 5 of the principal regulations (as amended by regulation 4 of the Telegraph Regulations 1977, Amendment No. 5) is hereby further amended—

(a) By omitting the expression “8c”, and substituting the expression “12c”:

(b) By omitting the expression “\$1.25”, and substituting the expression “\$1.85”.

(2) The Telegraph Regulations 1977, Amendment No. 5 are hereby consequentially amended by revoking regulation 4.

**5. Collect telegrams**—(1) Regulation 6 of the principal regulations (as amended by regulation 5 of the Telegraph Regulations 1977, Amendment No. 5) is hereby further amended by omitting the expression “35c”, and substituting the expression “50c”.

(2) The Telegraph Regulations 1977, Amendment No. 5 are hereby consequentially amended by revoking regulation 5.

**6. Decorative stationery**—(1) Regulation 7 of the principal regulations (as amended by regulation 6 of the Telegraph Regulations 1977, Amendment No. 5) is hereby further amended by omitting the expression “75c”, and substituting the expression “\$1.00”.

(2) The Telegraph Regulations 1977, Amendment No. 5 are hereby consequentially amended by revoking regulation 6.

**7. Multiple telegrams**—(1) Regulation 8 of the principal regulations (as amended by regulation 7 of the Telegraph Regulations 1977, Amendment No. 5) is hereby further amended by omitting from paragraph (b) the expression “\$1.50”, and substituting the expression “\$2.25”.

(2) The Telegraph Regulations 1977, Amendment No. 5 are hereby consequentially amended by revoking regulation 7.

**8. Weather telegrams**—The principal regulations are hereby amended by revoking regulation 9.

**9. Cancellation of telegrams**—(1) Regulation 12 of the principal regulations (as amended by regulation 9 of the Telegraph Regulations 1977, Amendment No. 5) is hereby further amended by omitting the expression “30c”, in both places where it occurs, and substituting in each case the expression “45c”.

(2) The Telegraph Regulations 1977, Amendment No. 5 are hereby consequentially amended by revoking regulation 9.

**10. Facsimile service**—Regulation 15A (2) of the principal regulations (as substituted by regulation 10 of the Telegraph Regulations 1977, Amendment No. 5) is hereby amended—

- (a) By omitting from paragraph (a) the expression “\$2.00”, and substituting the expression “\$2.50”;
- (b) By omitting from paragraph (a) the expression “70c”, and substituting the expression “85c”;
- (c) By omitting from paragraph (a) the expression “50c”, and substituting the expression “60c”;
- (d) By omitting from paragraphs (b) and (c) the expression “\$4.00”, and substituting the expression “\$6.00”.

**11. Press telegrams**—(1) Regulation 16 of the principal regulations (as substituted by regulation 11 of the Telegraph Regulations 1977, Amendment No. 5) is hereby amended by revoking subclause (1), and substituting the following subclause:

“(1) Inland press telegrams shall be accepted only at a telegraph office equipped with a telex gentex connection when in attendance or when such telegraph office has been reopened as provided in regulation 22 of these regulations:”

(2) Regulation 16 of the principal regulations (as so substituted) is hereby further amended—

- (a) By omitting from subclause (2) the expression “\$2.55”, and substituting the expression “\$3.85”;
- (b) By omitting from subclause (3) the expression “\$3.30”, and substituting the expression “\$4.95”.

**12. Money order telegrams**—Regulation 16A of the principal regulations (as inserted by regulation 12 of the Telegraph Regulations 1977, Amendment No. 5) is hereby amended—

- (a) By omitting the expression “\$7.50”, and substituting the expression “\$10.00”;
- (b) By omitting the expression “\$9.00”, and substituting the expression “\$12.25”;
- (c) By omitting the figure “15”, and substituting the figure “20”.

**13. Carriage charges during the ordinary rate period**—(1) Regulation 19 (1) of the principal regulations (as substituted by regulation 15 of the Telegraph Regulations 1977, Amendment No. 1 and amended by regulation 14 of the Telegraph Regulations 1977, Amendment No. 5) is hereby further amended by omitting the expression “\$1.50”, and substituting the expression “\$2.25”.

(2) The Telegraph Regulations 1977, Amendment No. 5 are hereby consequentially amended by revoking regulation 14.

**14. Delivery fee during the after-hour period**—(1) Regulation 19A of the principal regulations (as substituted by regulation 15 of the Telegraph Regulations 1977, Amendment No. 1 and as amended by regulation 15 of the Telegraph Regulations 1977, Amendment No. 5) is hereby further amended—

(a) By omitting from subclause (1) the expression “\$4.50”, and substituting the expression “\$6.75”:

(b) By omitting from subclause (2) the expression “\$4.50”, and substituting the expression “\$6.75”.

(2) The Telegraph Regulations 1977, Amendment No. 5 are hereby consequentially amended by revoking regulation 15.

**15. Redelivery of telegrams**—(1) Regulation 20 of the principal regulations (as amended by regulation 16 of the Telegraph Regulations 1977, Amendment No. 1) is hereby further amended by omitting the expression “50c”, and substituting the expression “\$1.10”.

(2) Regulation 16 of the Telegraph Regulations 1977, Amendment No. 1 is hereby consequentially amended by revoking paragraph (b).

**16. Reopening of office for press telegrams**—(1) Regulation 22 of the principal regulations (as amended by regulation 16 of the Telegraph Regulations 1977, Amendment No. 5) is hereby further amended by omitting the expression “\$30”, and substituting the expression “\$45”.

(2) The Telegraph Regulations 1977, Amendment No. 5 are hereby consequentially amended by revoking regulation 16.

**17. Code addresses**—(1) Regulation 24 of the principal regulations (as amended by regulation 17 of the Telegraph Regulations 1977, Amendment No. 5) is hereby further amended—

(a) By omitting from subclause (1) the expression “40”, and substituting the expression “45”:

(b) By omitting from subclause (1) the expression “10”, and substituting the expression “11.25”.

(2) Regulation 17 of the Telegraph Regulations 1977, Amendment No. 5 are hereby consequentially amended by revoking paragraphs (a) and (b) of subclause (1).

**18. Inspection of original telegram**—(1) Regulation 26 of the principal regulations (as amended by regulation 18 of the Telegraph Regulations 1977, Amendment No. 5) is hereby further amended—

- (a) By omitting from paragraph (a) of subclause (2) the expression "\$1.50", and substituting the expression "\$2.25":
- (b) By omitting from paragraphs (b) and (c) of subclause (2) the expression "\$3.00", and substituting in each case the expression "\$4.50".
- (2) The Telegraph Regulations 1977, Amendment No. 5 are hereby consequentially amended by revoking regulation 18.

**19. Copy of telegram**—(1) Regulation 27 (1) of the principal regulations (as amended by regulation 19 of the Telegraph Regulations 1977, Amendment No. 5) is hereby further amended by omitting the expression "\$1.50", and substituting the expression "\$2.25".

(2) The Telegraph Regulations 1977, Amendment No. 5 are hereby consequentially amended by revoking regulation 19.
