THE TRANSPORT (VEHICLE REGISTRATION AND LICENSING) NOTICE 1985

PURSUANT to sections 14A and 14B (5) of the Transport Act 1962, the Minister of Transport hereby gives the following notice.

NOTICE

1. Title and commencement—(1) This notice may be cited as the Transport (Vehicle Registration and Licensing) Notice 1985.

(2) This notice shall come into force on the 14th day after the date of its notification in the *Gazette*.

- **2. Interpretation**—In this notice, unless the context otherwise requires,— "The Act" means the Transport Act 1962:
 - "Heavy trailer" means a trailer that with the load it is for the time being carrying weighs more than 2000 kilograms:
 - "Licensing year" means the period commencing on the 1st day of July in one year and ending with the 30th day of June in the following year:
 - "Light trailer" means a trailer that with the load it is for the time being carrying weighs not more than 2000 kilograms.

3. Application—This notice shall apply in respect of the licensing year commencing with the 1st day of July 1985, and every subsequent licensing year.

4. Registration plates—(1) The distinguishing marks on registration plates shall be embossed and coloured aluminium on a black background. (2) Registration plates shall bear distinguishing marks as follows:

- (a) For plates that are trade plates used in accordance with section 22 of
 - the Act, a series of numerals preceded or followed by the letter "D":
- (b) For plates for motor cycles, mopeds, tractors, and trailers,-

(i) A series of numerals from 1 to 99 999 (both numbers inclusive); or

(ii) A series of numerals from 1 to 999 (both numbers inclusive) followed by any combination of 2 or 3 letters of the alphabet:

(c) For plates for motor vehicles the distinguishing marks for which are not prescribed by any of the foregoing provisions of this subclause, a series of numerals from 1 to 9999 (both numbers inclusive) preceded by any combination or combinations of 2 letters of the alphabet. 5. Registration plates for official vehicles—Notwithstanding anything in clause 4 of this notice, the registration plates of any motor vehicle that is the property of or regularly used by the Governor-General, and any motor vehicle that is operated or regularly used by a government, person, or organisation described in the first column of the table to this clause, shall be distinguished solely by the symbol or, as the case may be, the letters and numerals specified in the second column of that table.

(a) In the case of a motor vehicle other than a motor vehicle of any of the kinds specified in paragraph (b) of this clause, one plate shall be displayed on the front of the vehicle and one plate shall be

(b) In the case of any motor cycle, moped, tractor, or trailer one plate shall be displayed on the rear of the vehicle in an upright position and so displayed that every letter, figure, and distinguishing mark on the plate is easily visible.

7. Form of licences—(1) Except as provided in subclause (2) of this notice, licences to use motor vehicles of the following classes shall be in the following forms:

- (a) For every motor cycle, other than a motor cycle to which paragraph (g) of this subclause applies, the licence shall be in the form of Diagram No. 1 in the First Schedule to this notice:
- (b) For every moped, light trailer, heavy trailer, or tractor, other than a vehicle to which paragraph (c) or paragraph (f) or paragraph (g) of this subclause applies, the licence shall be in the form of Diagram No. 3 in that Schedule:
- (c) For every heavy trailer that is required to have a certificate of fitness or permit, the licence shall be in the form of Diagram No. 4 in that Schedule:
- (d) For every motorcar, other than a motorcar to which paragraph (e) or paragraph (f) of this subclause applies, the licence shall be in the form of Diagram No. 6 in that Schedule:
- (e) For every motor vehicle that is required to have a certificate of fitness or permit, other than a vehicle to which paragraph (f) or paragraph (g) of this subclause applies, the licence shall be in the form of Diagram No. 7 in that Schedule:
- (f) For every motor vehicle operated under a transport licence, other than a trailer or a vehicle to which paragraph (g) of this subclause applies, the licence shall be in the form of Diagram No. 8 in that Schedule:
- (g) For every motor cycle or moped operated under a transport licence, the licence shall be in the form of Diagram No. 9 in that Schedule:
- (h) For every motor vehicle for which the form of licence is not prescribed by any other paragraph of this subclause, the licence shall be in the form of Diagram No. 10 in that Schedule.

(2) The licences to use motor vehicles of the following classes shall be in the following forms:

- (a) For every motor cycle or moped to which there is required to be attached a learner's licence label, the licence shall be in the form of Diagram No. 2 in the First Schedule to this notice:
- (b) For every motor vehicle operated under section 22 of the Act (which relates to trade plates) or of a kind specified in the Second Schedule to this notice, the licence shall be in the form of Diagram No. 3 in the First Schedule to this notice:
- (c) For every motor vehicle that is an exempted vehicle within the meaning of section 187 of the Act, the licence shall be in the form of Diagram No. 5 in the First Schedule to this notice.

(3) Every licence shall be so made that it can be affixed to the vehicle to which it relates in the manner prescribed in clause 8 of this notice. (4) It shall not be necessary for any licence that complies with the

(4) It shall not be necessary for any licence that complies with the provisions of this notice to refer to the assigned registration number of the vehicle to which it relates.

8. Display of licences—(1) Except as provided in subclause (3) of this clause, the licence issued for any vehicle shall be displayed as follows:

(a) In the case of a motor cycle, moped, tractor, or trailer, the licence shall be affixed to the registration plate on the right-hand side:

- (b) In the case of any other vehicle fitted with a windscreen, the licence shall be affixed to the top or bottom of the windscreen as near as practicable to the middle line of the windscreen and so as to be easily visible from the front of the vehicle:
- (c) In the case of any other vehicle not fitted with a windscreen, the licence shall be affixed on the front or on the back or on the right of the vehicle.

(2) In each such case the licence shall be displayed in an upright easily visible position and fixed so as not to be readily detachable from the windscreen, plate, or vehicle, as the case may be.

(3) Licences issued as trade licences shall be displayed as follows:

- (a) In the case of a motor cycle, moped, tractor, or trailer, the licence shall be affixed to the registration plate on the right-hand side:
- (b) In the case of any other vehicle, the licence shall be affixed to the rear registration plate on the right-hand side.

9. Fees—The following fees shall be payable in respect of the issue of registration plates, licences, and duplicate certificates of registration to cover the cost of their production and issue:

SECOND SCHEDULE

SPECIFIED MOTOR VEHICLES

EXPLANATORY NOTE

This note is not part of the notice, but is intended to indicate its general effect.

This notice specifies the form and prescribed manner of affixing registration plates and licences to motor vehicles and the fees for plates, licences, and duplicate certificates of registration. These matters were formerly dealt with in the Motor Vehicle Registration and Licensing Regulations 1965 that were revoked by the Transport Regulations Revocation Order 1985 (S.R. 1985/69). The notice applies in respect of the licensing year commencing with 1 July 1985, and subsequent licensing years.
