## THE TRANSPORT (VEHICLE REGISTRATION AND LICENSING) NOTICE 1986, AMENDMENT NO. 4

PURSUANT to sections 14 (3) and 15 (6) of the Transport (Vehicle and Driver Registration and Licensing) Act 1986, the Minister of Transport hereby gives the following notice.

## NOTICE

1. Title and commencement—(1) This notice may be cited as the Transport (Vehicle Registration and Licensing) Notice 1986, Amendment No. 4, and shall be read together with and deemed part of the Transport (Vehicle Registration and Licensing) Notice 1986\* (hereinafter referred to as the principal notice).

(2) This notice shall come into force on the 1st day of July 1989.

2. Fees—The principal notice is hereby amended by revoking clause 8 (as substituted by clause 2 of the Transport (Vehicle Registration and Licensing) Notice 1986, Amendment No. 3), and substituting the following clause:

"8. (1) The following fees shall be payable in respect of the issue of registration plates (excluding personalised registration plates), licences, and duplicate certificates of registration to cover the cost of their production and issue:

"(2) A fee of 20.50 shall be payable in respect of the production and issue of personalised registration plates.

"(3) The fees prescribed by this clause are inclusive of goods and services tax at the rate of 12.5 percent payable under the Goods and Services Tax Act 1985."

**3. Revocation**—The Transport (Vehicle Registration and Licensing) Notice 1986, Amendment No. 3 is hereby consequentially revoked.

## EXPLANATORY NOTE

This note is not part of the notice, but is intended to indicate its general effect.

This notice increases the fees payable in respect of registration plates, licences, and duplicate certificates of registration to reflect the increase in goods and services tax from 10 percent to 12.5 percent. The increases come into force on 1 July 1989.
