**ORDER IN COUNCIL**

At Wellington this 25th day of September 1995

Present:

HER EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to sections 35A and 48 of the Transport (Vehicle and Driver Registration and Licensing) Act 1986, Her Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

**REGULATIONS**

**1. Title and commencement**—(1) These regulations may be cited as the Transport (Vehicle Registration and Licensing) Regulations 1994, Amendment No. 2, and shall be read together with and deemed part of the Transport (Vehicle Registration and Licensing) Regulations 1994\* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 30th day of October 1995.

**2. Annual licence fees and licence administration fee**—The principal regulations are hereby amended by revoking Part II of the Second Schedule, and substituting the Part II and Part IIA set out in the Schedule to these regulations.

**3. Revocation**—Part III of the Second Schedule to the principal regulations is hereby revoked.

SCHEDULE

NEW PART II AND PART IIA SUBSTITUTED IN SECOND SCHEDULE TO  
PRINCIPAL REGULATIONS

“PART II

ANNUAL LICENCE FEES

1. For any motorcycle having a motor the total piston displacement of which exceeds 60 cubic centimetres ...	24.50
2. For any other motorcycle and for any moped ...	14.50
3. (a) For any motor vehicle manufactured before 1 January 1919 ...	10.50
(b) For any motor vehicle (not being a motorcycle or moped to which clause 2 applies) manufactured after 31 December 1918 but not later than 40 years before the date of licensing ...	19.50
4. For any trailer that with the load it is for the time being carrying does not weigh more than 2000 kilograms ...	24.50
5. For any tractor or any self-propelled agricultural machine ...	24.50
6. For any traction engine ...	10.50
7. For any all-terrain vehicle ...	24.50
8. For any other motor vehicle ...	43.50
9. For any trade licence for use on a motorcycle or moped ...	24.50
10. For any trade licence for use on any other motor vehicle ...	43.50

Nothing in clauses 1, 2, 4, 5, and 8 of this Part of this Schedule shall apply with respect to any motor vehicle to which clause 3 of this Part applies.

LICENCE APPLICATION ADMINISTRATION FEE

Administration fee for each application for a licence ... .. \$6.50  
This fee is in addition to any fee prescribed in Part II of this Schedule.”

## EXPLANATORY NOTE

*This note is not part of the regulations, but is intended to indicate their general effect.*

These regulations, which come into force on 30 October 1995, amend the Transport (Vehicle Registration and Licensing) Regulations 1994.

*Regulation 2* revokes Part II of the Second Schedule to the principal regulations, and substitutes a new Part II and Part II $\Lambda$ . Part II prescribes a new list of annual licence fees for motor vehicles. Part II $\Lambda$  prescribes a licence application fee of \$6.50. The licence application fee is payable in addition to the annual licence fee.

*Regulation 3* revokes Part III of the Second Schedule. Part III prescribed a fee of \$23 for endorsement in the motor vehicle register of a change of ownership of a registered motor vehicle. The fee is now prescribed by the Transport (Change of Ownership) Regulations 1995.
