

## THE TRANSPORT (CHILD RESTRAINTS AND SEAT BELTS APPROVAL) NOTICE 1984

Pursuant to section 77B of the Transport Act 1962, the Secretary for Transport hereby gives the following notice.

#### NOTICE

- 1. Title and commencement—(1) This notice may be cited as the Transport (Child Restraints and Seat Belts Approval) Notice 1984.
  - (2) This notice shall come into force on the 1st day of September 1984.
- 2. Approved child restraints—(1) The following child restraints are hereby approved for the purposes of regulations 30 and 30A of the Traffic Regulations 1976\* in respect of all vehicles so long as the child restraints are fitted and used in accordance with the standard concerned:
  - (a) Child restraints that comply with New Zealand Standard 5411 and are labelled or otherwise marked accordingly:
  - (b) Child restraints that comply with Australian Standard 1754 and are labelled or otherwise marked accordingly:
  - (c) Child restraints that comply with Federal Motor Vehicle Safety Standard 213 of the United States of America and are labelled or otherwise marked accordingly:
  - (d) Child restraints that comply with British Standard 3254 and are labelled or otherwise marked accordingly:
  - (e) Child restraints that comply with Economic Commission for Europe regulation 44 and are labelled or otherwise marked accordingly:
  - (f) Child restraints that comply with Trafiksäkerhetsverk Författnings Samling 1978:3 (Sweden) and are labelled or otherwise marked accordingly.
- (2) The following child restraints are hereby approved for the purposes of regulations 30 and 30A of the Traffic Regulations 1976\* in respect of all vehicles so long as the child restraint is manufactured before the 1st day of January 1985:

- **3.** Approved seat belts—(1) Except to the extent that other provision is made under subclause (4) of this clause and subject to subclauses (2) and (3) of this clause, the following seat belts are hereby approved for the purposes of regulations 30, 30A, 30B, 78, 78A, 78C, and 78D of the Traffic Regulations 1976\* in respect of all vehicles:

(a) Seat belts that comply with New Zealand Standard 1662 or 5401 and

are labelled or otherwise marked accordingly:

(b) Seat belts manufactured in Australia and bearing the standard number "E35" of the Standards Association of Australia:

(c) Seat belts that comply with Australian Design Rule 4c and are labelled or otherwise marked accordingly:

(d) Seat belts that comply with Federal Motor Vehicle Safety Standard 209 of the United States of America and are labelled or otherwise marked accordingly:

(e) Seat belts that comply with British Standard BSAU 160 and are labelled

or otherwise marked accordingly:

(f) Seat belts that comply with Economic Commission for Europe regulation 16 and are labelled or otherwise marked accordingly:

(g) Seat belts that comply with E.E.C. Directive 77/541 and are labelled or otherwise marked accordingly.

(2) The seat belts approved under subclause (1) of this clause are approved for fitting in the front seat of vehicles to which regulation 78A of the Traffic Regulations 1976\* applies (other than 4-wheel drive vehicles) for the use of the driver and any passenger who may occupy the sitting position nearest the opposite side of the vehicle to the driver only if they include dual sensitive emergency locking retractors in the case of any vehicle.

(3) The seat belts approved under subclause (1) of this clause for fitting in sitting positions to the rear of the driver's seat are approved for fitting for the use of passengers who may occupy the sitting positions nearest the left and right sides of the vehicle only if they are 3-point lap and diagonal

seat belts.

- (4) The seat belts specified in the second column of the First Schedule to these regulations are hereby approved in respect of the specified sitting positions of the classes of vehicles described alongside them in the first column of that Schedule, but in respect of all other sitting positions of those vehicles the seat belts specified in subclause (1) of this clause are the approved seat belts.
- **4. Revocations**—The notices specified in the Second Schedule to this notice are hereby revoked.

#### SEAT BELTS APPROVED IN RESPECT OF SPECIFIED VEHICLES

#### **EXPLANATORY NOTE**

This note is not part of the notice, but is intended to indicate its general effect.

This notice specifies the child restraints and seat belts that are approved for the purposes of the Traffic Regulations 1976.

Some specified child restraints are approved only if they are manufactured before 1 January 1985. Such child restraints manufactured before that date will still be able to be used after that date. However, child restraints of those types may not be manufactured or sold after that date (see section 77c of the Transport Act 1962).

The approvals of seat belts are in similar terms to the Seat Belts Approval Notice 1974 (S.R. 1974/301) and the many Gazette notices relating to specific types of vehicles.
