PURSUANT to the Transport Act 1962, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

- 1. Title and commencement—(1) This order may be cited as the Transport Regulations Revocation Order 1985.
 - (2) This order shall come into force on the 1st day of May 1985.
- **2. Revocations**—The regulations specified in the Schedule to this order are hereby revoked.
- **3. Saving**—Notwithstanding the revocation of the Motor Vehicles Registration and Licensing Regulations 1965 by clause 2 of this order, those regulations shall continue in force in respect of the licensing year ending with the 30th day of June 1985 as if they had not been revoked.

EXPLANATORY NOTE

This note is not part of the order, but is intended to indicate its general effect.

This order revokes regulations relating to registration and licensing of motor vehicles, and 2 other regulations. The matters formerly dealt with in the Motor Vehicles Registration and Licensing Regulations 1965 are now dealt with in Part II of the Transport Act 1962 as amended earlier this year, and in Ministerial prescriptions under section 14A of that Act.

The revocation of the 2 other regulations is consequential upon the revocation of the Motor

The revocation of the 2 other regulations is consequential upon the revocation of the Motor Vehicles Registration and Licensing Regulations 1965, recent amendments to the Transport Act 1962, and the new Transport (Drivers Licensing) Regulations 1985.
