



**TRANSPORT (VEHICLE STANDARDS) AMENDMENT
REGULATIONS (NO. 2) 1997**

PURSUANT to sections 77 and 199 of the Transport Act 1962, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Transport (Vehicle Standards) Amendment Regulations (No. 2) 1997, and are part of the Transport (Vehicle Standards) Regulations 1990* (“the principal regulations”).

(2) These regulations come into force on 8 January 1998.

2. Door locks and hinges—The principal regulations are amended by revoking regulation 32.

3. Steering—The principal regulations are amended by revoking regulation 33.

4. Interior fittings—Regulation 34 of the principal regulations is amended by revoking subclauses (1) and (3).

5. Second Schedule amended—The Second Schedule of the principal regulations is amended by revoking items 21, 22, and 23.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 8 January 1998, amend the Transport (Vehicle Standards) Regulations 1990.

Regulation 2 revokes regulation 32 of the principal regulations, which prescribes standards for door locks and hinges. Standards relating to door locks and hinges are now contained in Land Transport Rule 32001—Vehicle Standards (Door Retention Systems).

Regulation 3 revokes regulation 33 of the principal regulations, which prescribes standards for items relating to steering in a motor vehicle. Standards relating to steering are now contained in Land Transport Rule 32003—Vehicle Standards (Steering Systems).

Regulation 4 amends regulation 34 of the principal regulations by revoking subclauses (1) and (3), which prescribe standards for the interior fittings of a motor vehicle and the design and construction of sun visors. Standards relating to interior fittings are now contained in Land Transport Rule 32002—Vehicle Standards (Interior Impact).

Regulation 5 amends the Second Schedule of the principal regulations by revoking items relating to door locks and hinges, steering column impact, and interior impact.

The Land Transport Rules 32001, 32002, and 32003 come into force on 1 January 1998.
