

THE TEACHERS' SALARIES REGULATIONS 1938, AMENDMENT NO. 3

C. L. N. NEWALL, Governor-General ORDER IN COUNCIL

At the Government House at Wellington, this 17th day of May, 1944

Present :

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Education Act, 1914, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

REGULATIONS

1. (1) These regulations may be cited as the Teachers' Salaries Regulations 1938, Amendment No. 3, and shall be read together with and deemed part of the Teachers' Salaries Regulations 1938* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 1st day of June, 1944.
2. (1) Clause 50 of the principal regulations is hereby amended by adding thereto the following subclauses :---

"(3) Notwithstanding anything to the contrary in the foregoing provisions of this clause, any person who is appointed as a junior assistant in a Native school may, with the approval of the Public Service Commissioner, be appointed at the commencing salary appropriate to the second or any later year of service, as prescribed in Schedule VI as set out in subclause (1) hereof, if, in the opinion of the Director, he is possessed of such educational attainments or of such teaching experience, in relation to the usual qualifications or experience of junior assistants in Native schools, as justify his appointment at the proposed commencing rate of salary.

"(4) Where any junior assistant is appointed, pursuant to the last preceding subclause, at a commencing salary in excess of the rate prescribed by the said Schedule VI for the first or any later year of service, his salary for each year of service thereafter shall be determined in accordance with the said Schedule as if, on his appointment, he had in fact completed service for the year or years for which a lower rate of salary than his commencing salary is prescribed."

(2) The provisions of subclauses (3) and (4) of clause 50 of the principal regulations (as set out in the last preceding subclause) may at any time within six months after the commencement of these regulations be applied, with the necessary modifications, to any junior assistant in a Native school appointed before the commencement of these regulations :

Provided that no increase of salary granted to a junior assistant under this subclause shall take effect from a date earlier than the date of the commencement of these regulations.

3. (1) In addition to the positions specified in column (1) of Schedule XII, as set out in clause 77 of the principal regulations, the following positions may be created :—

- (a) In respect of not more than one training college at any time, the position of "Lecturer in Charge of Post-primary Training", for which the minimum salary shall be £550 per annum and the maximum salary shall be £600 per annum; and
- (b) In respect of any training college, the position of "Librarian", for which the maximum and minimum salaries and the annual increments shall be the same as are prescribed for Assistant Lecturers.

(2) The said Schedule XII is hereby consequentially amended as follows :— \cdot .

- (a) By inserting in column (1), below the reference to Vice-Principal, the words: "Lecturer in Charge of Post-primary Training (at one training college only)":
- (b) By inserting, opposite the reference to "Lecturer in Charge of Post-primary Training", a reference to "£550" under the heading "Minimum" and a reference to "£600" under the heading "Maximum" in column (2), and a reference to "£25" under each of the headings "1st" and "2nd" in column (3):
- (c) By inserting, after the words "Assistant Lecturers", the words "and Librarian".

(3) Clause 80 of the principal regulations shall be read subject to the provisions of this clause.

4. (1) Clauses 112 and 113 of the principal regulations (as set out in clause 18 of the Education Amending Regulations 1941*) are hereby amended as follows :---

- (a) As to clause 112, by inserting the words "Senior Area Organizer" before the words "Area Organizer" in subclause
 (1) thereof:
- (b) As to clause 113, by inserting in column (1), above the reference to the position of "Senior Teacher at a Teachers' Training College", a reference to the position of "Senior Area Organizer"; by inserting in column (2), opposite the reference to "Senior Area Organizer", the letter "A"; and by inserting in column (3), opposite the same reference, the figures "100" in the sub-columns headed respectively "Male" and "Female".

(2) Not more than four physical-education teachers shall hold at the same time the position of Senior Area Organizer.

5. Clause 19 of the Education Amending Regulations 1941* is hereby amended as follows:---

- (a) By omitting the reference to "twelve shillings and sixpence", and substituting a reference to "fifteen shillings"; and
- (b) By adding the following words, "or, in lieu of such travellingallowance, may receive a refund of the actual and reasonable expenses incurred by him for board and lodging".
