THE TEACHERS' SALARIES REGULATIONS 1938, AMENDMENT NO. 2.

GALWAY, Governor-General.

ORDER IN COUNCIL.

At the Government House at Wellington, this 6th day of September, 1939.

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

Pursuant to the Education Act, 1914, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

REGULATIONS.

- 1. These regulations may be cited as the Teachers' Salaries Regulations 1938, Amendment No. 2.
- 2. These regulations shall be read together with and form part of the Teachers' Salaries Regulations 1938* (hereinafter referred to as the principal regulations).
- 3. These regulations shall come into operation on the day following notification in the *Gazette* of the making hereof.†
- **4.** Clause 18 of the principal regulations is further amended by inserting in subclause (2) thereof, next after the word and letter "or (b)", the words "to a married woman; or".
- 5. Clause 29 of the principal regulations is further amended by adding to subparagraph (ii) of paragraph (a) of subclause (6) thereof, next after the words "30th day of September, 1938", the words "unless he is entitled to a higher rate of salary under clause 24 of these regulations".
- 6. Clause 51 of the principal regulations is amended by inserting next after the words "provisions of", the words "clause 32 (substitution of assistant masters for assistant mistresses, or vice versa.)".

- 7. Clause 98 of the principal regulations is further amended by—
- (1) Revoking subclause (2) thereof, and substituting the following:—
 - "(2) Notwithstanding the provisions of subclause (1) of this clause,—
 - "(a) No certificated relieving teacher who has attended a teachers' training college as a Division C student or who has spent a period in specialist training in a training college or who has been employed as a probationary assistant shall receive salary lower than at the rate of £155 per annum while employed in any position other than that of sole teacher in a Grade I school:
 - "(b) The Senior Inspector may classify a relieving teacher in a grade (as shown in column (1) of Schedule XVI) lower (except a relieving teacher referred to in paragraph (a) hereof) or in a grade higher than his grading-number would place him in accordance with the grading-number shown in column (2) of the said Schedule"; and
- (2) Adding to subclause (8) thereof, next after the words "shall determine", the sentence: "The salary of a temporary teacher may at any time be revised by the Senior Inspector or by the Director".
- **8.** (1) Clause 101 of the principal regulations is amended by prefixing "(1)" to the text thereof.
 - (2) The following subclause shall be added to clause 101:—
- "(2) Notwithstanding the provisions of the preceding subclause, a relieving teacher who has completed a full school week's engagement shall be paid salary up to and including the Sunday of that week. A 'full school week' for the purposes of this subclause means Monday to Friday inclusive."
- **9.** Clause 105 of the principal regulations (as added by clause 37 of the Teachers' Salaries Regulations 1938, Amendment No. 1—Statutory Regulation 1938/172) is amended by revoking the words "means and" in subclause (5) hereof.
