

THE TEACHERS TRAINING COLLEGE REGULATIONS 1959. **AMENDMENT NO. 10**

ORDER IN COUNCIL

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

Pursuant to sections 67s and 203 of the Education Act 1964, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Teachers Training College Regulations 1959, Amendment No. 10, and shall be read together with and deemed part of the Teachers Training College Regulations 1959* (hereinafter referred to as the principal regulations).
- (2) These regulations shall come into force on the day after the date of their notification in the Gazette.

- 2. Interpretation—(1) Regulation 2 (1) of the principal regulations is hereby amended by revoking the definition of the term "Board" (as substituted by regulation 2 of the Teachers Training College Regulations 1959, Amendment No. 8), and substituting the following definition:
 - "'Board' means a Teachers College Council constituted or reconstituted, under regulation 3A (1) of these regulations, for the control and management of any teachers college or teachers colleges; and, in relation to any teachers college, means that college's Teachers College Council:
- (2) Regulation 2 (1) of the principal regulations is hereby further amended by revoking the definition of the term "Director", and substituting the following definition:
 - "'Director' means-
 - "(a) Before the 1st day of October 1989, the Director-General of Education; and
 - "(b) After the 30th day of September 1989, the Secretary of Education:".
- (3) Regulation 2 of the Teachers Training College Regulations 1959, Amendment No. 8 is hereby consequentially revoked.
- **3. Control of teachers colleges**—(1) The principal regulations are hereby amended by revoking regulation 3 (as substituted by regulation 3 of the Teachers Training College Regulations 1959, Amendment No. 8).
- (2) Regulation 3 of the Teachers Training College Regulations 1959, Amendment No. 8 is hereby consequentially revoked.
- **4. Admission of students**—(1) Regulation 13 of the principal regulations (as amended by regulation 3 of the Teachers Training College Regulations 1959, Amendment No. 2) is hereby amended by revoking subclauses (3) to (5), and substituting the following subclauses:
- "(3) The Minister, with the concurrence of the Minister of Finance, shall determine the number of applicants to be admitted as college students under the various divisions in each year; and the Director shall allocate among teachers colleges the number determined for each division.
- "(4) The Selection Committee or other selecting authority shall not select an applicant for admission to a teachers college unless—
 - "(a) The Selection Committee or selecting authority is satisfied that the applicant—

"(i) Is of good character and reputation; and

- "(ii) Is free from any physical or other defect incompatible with effective work as a teacher; and
 - "(iii) Is suitable for the work of teaching; and
- "(b) The applicant signs a declaration of intention to teach for a specified period after the completion of training, which declaration shall be in a form required by the Director from entrants to a teachers college.
- "(4A) The Selection Committee or selecting authority may ask an applicant to produce evidence which it considers necessary for the purpose of making a decision under subclause (4) of this regulation, including evidence necessary for the purpose of determining whether the applicant is free from any physical or other defect incompatible with effective work as a teacher.

"(5) Any applicant who is dissatisfied with the decision of the Selection Committee or selecting authority may request the Selection Committee or selecting authority to review that decision."

(2) Regulation 3 of the Teachers Training College Regulations 1959,

Amendment No. 2 is hereby consequentially revoked.

5. Selection of students—(1) The principal regulations are hereby amended by revoking regulation 18 and regulation 19, and substituting the following regulation:

"18. (1) There shall, for each division of a teachers college, be a Selection

Committee for the selection of students for admission to that division.

"(2) The composition of each Selection Committee shall be determined

from time to time by the Director by notice in the Education Gazette.

"(3) All applications for admission to the various divisions of a teachers college received by the Teachers College Council shall be considered by the

appropriate Selection Committee, which shall advise the Council of the order of merit of applications.

- "(4) A Teachers College Council shall admit to each division of a teachers college only those applicants who have been recommended by the Selection Committee for that division, and such applicants shall be admitted in the order recommended by the Selection Committee, but in no case shall the total number of applicants admitted to a teachers college in any division exceed the number determined by the Director in accordance with subclause (3) of regulation 4 of these regulations.
- "(5) Notwithstanding subclause (4) of this regulation, a student may be admitted to a teachers college in any division by way of transfer from another division where such a transfer is approved or required by the

Director."

(2) Regulation 6 of the Teachers Training College Regulations 1959, Amendment No. 3 is hereby consequentially revoked.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations change the systems for the control of teachers colleges and the

procedures for the admission and selection of students to teachers colleges.

Under the existing regulations (as amended in 1968), authority for the control and management of a teachers college vests in a Teachers College Council or an Education Board. These Boards cease to exist as from the close of 30 September 1989. The effect of the amendment is to vest the control and management of each teachers college in a Teachers College Council.

Under the existing regulations, as made in 1959,-

(a) Selection Committees appointed by Education Boards select the students who are admitted to teachers colleges for training as primary teachers; and

(b) Selection Committees appointed by the Director-General of Education select the students who are admitted to teachers colleges for training as secondary teachers. Until the close of 30 September 1989, the composition of Selection Committees for both classes of student teachers will be determined by the Director-General of Education. After that date, the composition of those Committees will be determined by the Secretary of Education.
