**THE TEACHERS TRAINING COLLEGE REGULATIONS 1959,  
AMENDMENT NO. 4**

ORDER IN COUNCIL

At the Government Buildings at Wellington this 8th day of March 1965

Present:

THE RIGHT HON. KEITH HOLYOAKE, C.H., PRESIDING IN COUNCIL

PURSUANT to the Education Act 1914, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. These regulations may be cited as the Teachers Training College Regulations 1959, Amendment No. 4, and shall be read together with and deemed part of the Teachers Training College Regulations 1959\* (hereinafter referred to as the principal regulations).

2. Regulation 14 of the principal regulations, as substituted by regulation 4 of the Teachers Training College Regulations 1959, Amendment No. 2, is hereby further amended—

(a) By revoking the proviso thereto:

(b) By inserting, after the words "equivalent thereto", the words "or have otherwise attained an educational standard which, in the opinion of the Director, makes him suitable for admission to the course of training in that division".

3. Regulation 17 of the principal regulations is hereby amended by revoking subclause (2), and substituting the following subclause:

"(2) Before any applicant is admitted to a teachers college as a Division U student, he shall, together with some person procured by him and approved by the Director, jointly and severally enter into and become bound by a bond in a form to be determined by the Director under which they jointly and severally undertake to pay to the Crown a specified sum except where the student complies with the circumstances specified in the bond under which the bond becomes void."

4. The principal regulations are hereby amended by inserting, after regulation 21, the following regulation:

“21A. Every student, admitted to a teachers college in a division in which students normally undertake a course of training for a longer period than one year, shall be admitted to that division on trial for the first year of the course of training. At the end of that year, the Board, after receiving a report from the Principal (or, in the case of a student in a post-primary department, the Associate Principal) on the promise shown by the student of suitability for the teaching profession, shall either confirm the admission of the student to the division or terminate his studentship.”

5. Regulation 39 of the principal regulations, as amended by regulation 9 of the Teachers Training College Regulations 1959, Amendment No. 3, is hereby further amended by omitting from paragraph (a) of subclause (1) the words “excepting a student of Division U”.

EXPLANATORY NOTE

*This note is not part of the regulations, but is intended to indicate their general effect.*

These regulations vary the prerequisites for admission to a teachers college in Division A or Division H. They also provide for pupils taking courses of more than one year to be on trial for the first year, and provide for a bond jointly and severally binding a Division U Student and his surety instead of the former agreement by the student and bond by the surety.
