ORDER IN COUNCIL

At the Government Buildings at Wellington this 21st day of February 1972

THE RIGHT HON. J. R. MARSHALL PRESIDING IN COUNCIL

PURSUANT to the Education Act 1964, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title—These regulations may be cited as the Teachers Training College Regulations 1959, Amendment No. 9, and shall be read together with and deemed part of the Teachers Training College Regulations 1959* (hereinafter referred to as the principal regulations).

2. Control of teachers colleges—The principal regulations are hereby amended by revoking regulation 3A (as inserted by regulation 3 of the Teachers Training College Regulations 1959, Amendment

No. 8), and substituting the following regulations:

"3A. (1) The Minister may from time to time, by notice in the Gazette, provide for the constitution or reconstitution of a Teachers College Council for the control and management of any teachers college or teachers colleges. Each Teachers College Council shall be known by such name and shall consist of such members and shall have the control and management of such college or colleges as may be specified in the notice.

"(2) Each Teachers College Council constituted or reconstituted under

subclause (1) of this regulation—

"(a) Shall be a body corporate and shall have perpetual succession and a common seal and may hold real and personal property for the purposes of the college or colleges and may sue and be sued and do and suffer all such acts and things as bodies corporate may do and suffer:

"(b) May, if it has the control and management of more than 1 college, establish for each college committees of management of its own members or representatives of its own members and may delegate such of its powers of control and management over a teachers college to each committee as the Minister may in writing agree:

"(c) May appoint officers for the administration of the teachers college or colleges; and the provisions of the Education Boards Employment Regulations 1958* shall apply to officers employed by the Council as if they were officers of an Education Board and as if every reference in those regulations to a Board or an Education Board were also a reference to a Teachers College Council constituted or reconstituted for the control of a teachers college or colleges.

"3B (1) In the event of the transfer of the control of a teachers college from one governing body to another, all the property, rights, and liabilities of the former governing body in respect of the teachers college shall vest without conveyance or assignment in and become the property, rights, and liabilities of the governing body to which control

of the teachers college has been transferred.

"(2) If, under subclause (1) of this regulation, any land vests in a governing body to which control of a teachers college has been transferred, the District Land Registrar for the land registration district in which the land is situated, on the deposit with him of such plans and documents as he may require, shall make such entries in the register and generally do all such things as may be necessary to give full effect to this regulation."

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.
