**THE TRANSPORT (ROYAL VISIT) TEMPORARY
AMENDMENT REGULATIONS 1953**

THE RIGHT HON. S. G. HOLLAND PRESIDING IN COUNCIL

PURSUANT to the Transport Act 1949, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. These regulations may be cited as the Transport (Royal Visit) Temporary Amendment Regulations 1953.

2. For the purpose of facilitating the conveyance of school children and others on the occasion of the visit to New Zealand of Her Majesty the Queen, a goods service vehicle and the owner or driver of a goods service vehicle for the time being in use for the conveyance of passengers to or from any place on the occasion of the visit to it of Her Majesty the Queen shall be exempted from the following requirements, namely:

- (a) As to the driver, from regulation 2 of the Motor Drivers Regulations 1940,* so far as it requires that the driver shall be the holder of a licence to drive a passenger service vehicle; and

- (b) As to the vehicle, from the requirements of regulation 9 of the Motor Vehicles Registration and Licensing Regulations 1949* that there be fitted to the vehicle registration plates having a series of numerals preceded by the letter "V".
3. These regulations shall expire on the 31st day of January 1954.

EXPLANATORY NOTE

[This note is not part of the regulations, but is intended to indicate their general effect.]

These regulations are for the purpose of facilitating the taking of school children and other parties of persons by goods service vehicle to various places on the occasion of the approaching visit to them of Her Majesty the Queen. These regulations provide that there will be no obligation to fit "V" registration plates to the vehicle and that the driver will not require to hold a passenger service vehicle driver's licence. The obligation to pay an additional insurance premium in respect of the carriage of passengers imposed by section 79 of the Transport Act 1949 is not affected.
