# THE WAIKATO AREA HEALTH DISTRICT (TRIENNIAL GENERAL ELECTION AND BOUNDARIES) ORDER 1989

## ORDER IN COUNCIL

At Wellington this 17th day of July 1989

### Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

Pursuant to section 5A of the Area Health Boards Act 1983 (as inserted by section 4 of the Area Health Boards Amendment Act 1989) and to section 5B of the Area Health Boards Act 1983 (as inserted by section 4 of the Area Health Boards Amendment Act (No. 2) 1989) and to subsections (3), (4), and (4A) of section 8 of the Area Health Boards Act 1983 (as amended by section 5 of the Area Health Boards Amendment Act 1989 and by section 5 of the Area Health Boards Amendment Act (No. 2) 1989) and to section 8A of the Area Health Boards Act 1983 (as inserted by section 6 of the Area Health Boards Amendment Act (No. 3) 1988), His Excellency the Governor-General, acting on a recommendation made by the Minister of Health after consultation by that Minister with the Waikato Area Health Board, the Thames Hospital Board, and the Taumarunui Hospital Board, and by and with the advice and consent of the Executive Council, hereby makes the following order.

## ORDER

- 1. Title and commencement—(1) This order may be cited as the Waikato Area Health District (Triennial General Election and Boundaries) Order 1989.
- (2) Except as provided in clause 12 (2) of this order, this order shall come into force on the 18th day of July 1989.
- 2. Abolition of Waikato Area Health District—The Waikato Area Health District is hereby abolished as from the close of the 10th day of December 1989 (being the 57th day after polling day for the next triennial general election of members of local authorities as prescribed by section 4 of the Local Elections and Polls Act 1976).
- **3. Abolition of Thames Hospital District**—The Thames Hospital District is hereby abolished as from the close of the 10th day of December 1989 (being the 57th day after polling day for the next triennial general election of members of local authorities as prescribed by section 4 of the Local Elections and Polls Act 1976).
- **4. Abolition of Taumarunui Hospital District**—The Taumarunui Hospital District is hereby abolished as from the close of the 10th day of December 1989 (being the 57th day after polling day for the next triennial general election of members of local authorities as prescribed by section 4 of the Local Elections and Polls Act 1976).
- 5. Constitution of Waikato Area Health District—A new area health district, under the name of the Waikato Area Health District, is hereby constituted on the 11th day of December 1989 (being the 58th day after polling day for the next triennial general election of members of local authorities as prescribed by section 4 of the Local Elections and Polls Act 1976).
- **6. Boundaries for triennial general election**—(1) It is hereby declared that, for the purposes of the triennial general election of members of local authorities to be held on the 14th day of October 1989 (as required by section 4 of the Local Elections and Polls Act 1976), the boundaries of the Waikato Area Health District, as constituted by clause 5 of this order, shall be deemed to be the boundaries of the land included within—
  - (a) The Hamilton City; and
  - (b) The Waikato District; and
  - (c) The Waipa District; and
  - (d) The Otorohanga District; and

- (e) The Waitomo District; and
- (f) The Ohura Ward, the National Park Ward, and the Taumarunui Ward of the Ruapehu District; and
- (g) The Thames Coromandel District; and
- (h) The Hauraki District; and
- (i) The Matamata-Piako District; and
- (i) The South Waikato District; and
- (k) The Taupo District.
- (2) The districts specified in paragraphs (a) to (k) of subclause (1) of this clause are all districts of territorial authorities named in the First Schedule to the Local Government Act 1974 (as substituted by clause 2 of the Local Government Act First Schedule Order (No. 2) 1989\*).
- **7. Boundaries on 58th day after polling day**—It is hereby declared that, on the 58th day after polling day for the triennial general election referred to in clause 6 of this order, the boundaries declared by that clause shall become the boundaries of the Waikato Area Health District, as constituted by clause 5 of this order.
- **8. Constituent districts**—It is hereby declared that, for the purposes of the triennial general election referred to in clause 6 of this order,—
  - (a) The area comprising the wards of Hamilton City known as the Chartwell-Fairfield Ward and the Hamilton East-Hillcrest Ward shall be a constituent district of the Waikato Area Health District; and
  - (b) The area comprising the wards of Hamilton City known as the North Central Ward, the Dinsdale-Nawton Ward, and the Melville-Lake Ward shall be a constituent district of the Waikato Area Health District; and
  - (c) The area comprising the wards of the Waikato District known as the Huntly Ward, the Ngaruawahia Ward, the Raglan Ward, the Whangamarino Ward, the Maungakawa Ward, the Whangape Ward, the Whaingaroa Ward, the Newcastle Ward, and the Hukanui Ward shall be a constituent district of the Waikato Area Health District; and
  - (d) The area comprising—
    - (i) The wards of the Waikato District known as the Eureka Ward and the Tamahere Ward; and
    - (ii) The Waipa District, shall be a constituent district of the Waikato Area Health District; and
  - (e) The Otorohanga District and the Waitomo District shall each be a constituent district of the Waikato Area Health District; and
  - (f) The wards of the Ruapehu District known as the Ohura Ward, the National Park Ward, and the Taumarunui Ward shall each be a constituent district of the Waikato Area Health District; and
  - (g) The Thames-Coromandel District, the Hauraki District, the Matamata-Piako District, the South Waikato District, and the Taupo District shall each be a constituent district of the Waikato Area Health District.

- **9. Number of representatives of constituent districts**—The number of representatives on the Waikato Area Health Board of each constituent district declared by clause 8 of this order (not being a constituent district to which clause 10 of this order applies) shall be as specified in the Schedule to this order.
- 10. Combined districts—(1) For the purpose of the election of representatives on the Waikato Area Health Board,—
  - (a) The constituent districts declared by paragraphs (e) and (f) of clause 8 of this order are hereby combined into a combined district; and
  - (b) The Hauraki District and the Matamata-Piako District are hereby combined into a combined district.
- (2) The number of members to be elected in common as the representatives of each such combined district shall be as specified in the Schedule to this order.
- 11. Conduct of elections—(1) For the purpose of the conduct of elections held within the constituent district declared by clause 8 (a) of this order,—
  - (a) The Hamilton City Council (as constituted on the commencement of this clause) is hereby selected and appointed to conduct elections held within that constituent district before the 1st day of November 1989; and
  - (b) The Hamilton City Council (as constituted by the Local Government (Waikato Region) Reorganisation Order 1989) is hereby selected and appointed to conduct elections held within that constituent district on or after the 1st day of November 1989.
- (2) For the purpose of the conduct of elections held within the constituent district declared by clause 8 (b) of this order,—
  - (a) The Hamilton City Council (as constituted on the commencement of this clause) is hereby selected and appointed to conduct elections held within that constituent district before the 1st day of November 1989; and
  - (b) The Hamilton City Council (as constituted by the Local Government (Waikato Region) Reorganisation Order 1989) is hereby selected and appointed to conduct elections held within that constituent district on or after the 1st day of November 1989.
- (3) For the purpose of the conduct of elections held within the constituent district declared by clause 8 (c) of this order,—
  - (a) The Waikato County Council (as constituted on the commencement of this clause) is hereby selected and appointed to conduct elections held within that constituent district before the 1st day of November 1989; and
  - (b) The Waikato District Council (as constituted by the Local Government (Waikato Region) Reorganisation Order 1989) is hereby selected and appointed to conduct elections held within that constituent district on or after the 1st day of November 1989.
- (4) For the purpose of the conduct of elections held within the constituent district declared by clause 8 (d) of this order,—
  - (a) The Te Awamutu Borough Council (as constituted on the commencement of this clause) is hereby selected and appointed

to conduct elections held within that constituent district before the 1st day of November 1989; and

(b) The Waipa District Council (as constituted by the Local Government (Waikato Region) Reorganisation Order 1989) is hereby selected and appointed to conduct elections held within that constituent district on or after the 1st day of November 1989.

(5) For the purpose of the conduct of elections held before the 1st day of November 1989 within the combined district created by clause 10 (1) (a) of this order, the Otorohanga District Council (as constituted on the commencement of this clause) is hereby selected and appointed to be the

principal local authority of the combined district.

(6) For the purpose of the conduct of elections held on or after the 1st day of November 1989 within the combined district created by clause 10(1)(a) of this order, the Otorohanga District Council (as constituted by the Local Government (Waikato Region) Reorganisation Order 1989) is hereby selected and appointed to be the principal local authority of the combined district.

(7) For the purpose of the conduct of elections held before the 1st day of November 1989 within the combined district created by clause 10 (1) (b) of this order, the Matamata Borough Council (as constituted on the commencement of this clause) is hereby selected and appointed to be the

principal local authority of the combined district.

(8) For the purpose of the conduct of elections held on or after the 1st day of November 1989 within the combined district created by clause 10 (1) (b) of this order, the Matamata-Piako District Council (as constituted by the Local Government (Waikato Region) Reorganisation Order 1989) is hereby selected and appointed to be the principal local authority of the combined district.

- 12. Revocation—(1) The Waikato Area Health District Order 1989\* is hereby revoked.
  - (2) This clause shall come into force on the 11th day of December 1989.

# EXPLANATORY NOTE

This note is not part of the order, but is intended to indicate its general effect.

This order—

- (a) Abolishes the Waikato Area Health District, the Thames Hospital District, and the Taumarunui Hospital District as from the close of 10 December 1989; and
- (b) Constitutes on 11 December 1989 a new area health district under the name of the Waikato Area Health District; and
- (c) Declares the boundaries that are to be deemed to be the boundaries of the Waikato Area Health District for the purposes of the triennial general election of members of local authorities to be held on 14 October 1989; and
- (d) Declares the areas that are to be constituent districts of the Waikato Area Health District for the purposes of that election.
- On 11 December 1989 (the 58th day after polling day for that election) the boundaries so declared will become the boundaries of the Waikato Area Health District and the constituent districts so declared will become constituent districts of that area health district.

Some constituent districts are combined into combined districts for the purpose of the election of representatives on the area health board.

At the triennial general election to be held on 14 October 1989, no election will take place in relation to the Waikato Area Health Board, the Thames Hospital Board, and the Taumarumui Hospital Board (the Boards being abolished). The representatives on those Boards at the close of the day before polling day will continue to hold office until the close of 10 December 1989.
