### HIS EXCELLENCY THE GOVERNOR GENERAL IN COUNCIL

PURSUANT to the Weights and Measures Act 1925, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

### REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Weights and Measures Regulations 1926–1951, Amendment No. 18, and shall be read together with and deemed part of the Weights and Measures Regulations 1926–1951\* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 1st day of October 1986.

2. Examination fees—Part II of the principal regulations is hereby amended by revoking regulation 4A (as substituted by regulation 2 of the Weights and Measures Regulations 1926–1951, Amendment No. 16), and substituting the following regulation:

"4A. The examination fee shall be the highest of the following fees:

- "(a) In the case of a weight, measure of capacity, or measure of length, \$150:
- "(b) In the case of a weighing or measuring instrument (not being a digital weighing instrument fitted with a computer), \$600:
- "(c) In the case of a digital weighing instrument fitted with a computer, \$750:
- "(d) In the case of a farm milk tank or a bulk tank, \$300."

**3. New scale of fees prescribed**—The principal regulations are hereby amended by revoking Part IV (as substituted by regulation 3 of the Weights and Measures Regulations 1926-1951, Amendment No. 16), and substituting the Part IV set out in the Schedule to these regulations.

4. Revocation—The Weights and Measures Regulations 1926-1951, Amendment No. 16 are hereby consequentially revoked.

#### General Provisions

- 16. Where any weight or common measure of capacity is adjusted, or any weight, measure, or weighing or measuring instrument is rejected as incorrect or otherwise unsuitable, a fee shall be charged which fee shall be equivalent to the fee set out in this Schedule for verifying (or reverifying) and stamping that weight, measure, or weighing or measuring instrument.
- 17. For the testing of weights or measures, or weighing or measuring instruments at premises other than an Inspector's office, owners shall, when requested, provide cartage for the necessary weights or other heavy equipment involved, and make available such equipment as an Inspector may require to perform suitable tests and such labour as is required to handle the weights and equipment:

Provided that, in the case of the testing of a weighbridge, the Inspector may arrange for the transportation of the necessary test weights if the owner undertakes to pay the charges for their transportation."

#### EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 1 October 1986, amend the Weights and Measures Regulations 1926-1951.

Regulation 2 amends Part II of the principal regulations by substituting a new regulation 4A relating to novel appliances. The new regulation 4A prescribes an increased scale of examination fees for such appliances.

Regulation 3 prescribes a new, simplified, scale of fees in relation to the testing of weights and measures and of weighing and measuring instruments. While the overall effect of the new scale is to increase fees, some fees are reduced.
