Present :

THE RIGHT HON. W. NASH PRESIDING IN COUNCIL

PURSUANT to the Weights and Measures Act, 1925, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

REGULATIONS

1. (1) These regulations may be cited as the Weights and Measures Regulations 1926, Amendment No. 7.

(2) These regulations shall be read together with and deemed part of the Weights and Measures Regulations 1926\* (hereinafter referred to as the principal regulations).

(3) The principal regulations, as amended by these regulations, may be cited as the Weights and Measures Regulations 1926-1948.

2. Regulation 1 of Part V of the principal regulations is revoked, and the following substituted :—
