THE WAR BURSARY REGULATIONS 1939.

GALWAY, Governor-General.

ORDER IN COUNCIL.

At the Government House at Wellington, this 20th day of
September, 1939.

Present :

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

PURSUANT to the Education Act, 1914, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

REGULATIONS.

1. These regulations may be cited as the War Bursary Regulations 1939.

2. These regulations shall come into force on the 1st day of January, 1940.

3. The regulations made by Order in Council dated the 22nd day of December, 1917,* and the War Bursary Regulations 1917, Amendment No. 1,† are revoked.

4. A bursary may be awarded under these regulations to a young person of either sex who is certified by the War Pensions Board to be or to have been the dependant of a member of the New Zealand Expeditionary Forces whose death has been found to have resulted from active military service, or who as a result of such service has suffered disablement the nature and extent of which in the opinion of the Board warrants the award of a bursary to such young person, and—

- (a) Who is receiving instruction at technical classes other than the classes of a technical high school ; or
- (b) Who is receiving at a school approved by the Director of Education a full-time course of instruction of a standard higher than that prescribed for Form II in the Syllabus of Instruction for Public Schools ; or
- (c) Who is enrolled on the books of a constituent college of the University of New Zealand or at a University Agricultural College and is attending lectures thereat.

5. A young person who is qualified under one of the paragraphs (a), (b), or (c) of the last preceding clause, and who is certified by the Principal of the school or college attended by him to have been in regular attendance and to have proved satisfactory in conduct, progress, and diligence, may receive a monetary grant in aid of necessary incidental expenditure incurred during the period of his attendance as follows :—

If qualified under paragraph (a), an allowance at the rate of £1 10s. per annum, provided that if the young person attends day-classes regularly for at least eight half-days a week he may receive an allowance at the rate of £5 per annum ; if qualified under paragraph (b), an allowance at the rate of £5 per annum ; if qualified under paragraph (c), an allowance at the rate of £10 per annum.

6. If, in the opinion of the Director of Education, a young person to whom these regulations apply is obliged to live away from home or his usual place of residence in order to prosecute his studies he may receive by way of boarding-allowance an additional payment at the rate of £30 per annum, provided he is devoting his whole time to his studies.

7. Where the young person lives at home and is, in the opinion of the Director of Education, obliged to travel more than four miles daily each way in order to prosecute his studies and is devoting his whole time to his studies he may receive as travelling-allowance a refund of the amount actually and necessarily expended by him in such travelling up to a maximum of £10 per annum.

8. A young person qualified under paragraph (a) of clause 4 of these regulations who attends day-classes regularly for at least eight half-days a week may receive the allowances payable under the provisions of clauses 6 and 7 hereof.

9. A bursary under these regulations shall not be tenable after the holder attains the age of twenty-three years.
