ORDER IN COUNCIL

At Wellington this 14th day of December 1987

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 30 of the Wanganui Computer Centre Act 1976, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

- 1. Title and commencement—(1) This order may be cited as the Wanganui Computer Centre Order 1987.
- (2) This order shall come into force on the day after the date of its notification in the Gazette.
- 2. Use of computer system for further information—(1) The computer system may be used for the storage, processing, and retrieval of the information specified in the Schedule to this order.
- (2) The storage, processing, and retrieval of the information specified in the Schedule to this order is subject to the conditions specified in relation thereto in that Schedule.

(d) Whose firearms licence has been revoked under section 27 (1) of the Arms Act 1983

EXPLANATORY NOTE

This note is not part of the order, but is intended to indicate its general effect.

This order varies and extends the use that may be made of the computer system under the Wanganui Computer Centre Act 1976 in 3 areas:

- (a) The Police Department is afforded access to the Department of Justice records relating to fines enforcement to obtain information relevant to the execution of writs, warrants, and orders issued or made on default in the payment of fines:
- (b) The Police Department is authorised to use the system for the storage, processing, and retrieval of records kept by the Police Department in relation to persons who have been refused firearms authorities or whose firearms authorities have been revoked:
- (c) The Ministry of Transport is authorised to use the system for the storage, processing, and retrieval of records required to establish a national register of transport licences.
