



THE WORK CENTRES NOTICE 1982

PURSUANT to section 4 of the Criminal Justice Amendment Act 1962, the Minister of Justice hereby gives the following notice.

NOTICE

1. Title and commencement—(1) This notice may be cited as the Work Centres Notice 1982.

(2) This notice shall take effect from the 1st day of June 1982.

2. Constitution of Johnston Street Work Centre—The land described in the First Schedule to this notice is hereby declared to be a non-residential work centre, to be known as the Johnston Street Work Centre, for males aged at the time of sentence not less than 15 years.

3. Constitution of Goodshed Road Work Centre—The land described in the Second Schedule to this notice is hereby declared to be a non-residential work centre, to be known as the Goodshed Road Work Centre, for males aged at the time of sentence not less than 15 years.

4. Constitution of Alfred Street Work Centre—The land described in the Third Schedule to this notice is hereby declared to be a non-residential work centre, to be known as the Alfred Street Work Centre, for males aged at the time of sentence not less than 15 years.

5. Constitution of Albert Street Work Centre—The land described in the Fourth Schedule to this notice is hereby declared to be a non-residential work centre, to be known as the Albert Street Work Centre, for males aged at the time of sentence not less than 15 years.

6. Constitution of High Street Work Centre—The land described in the Fifth Schedule to this notice is hereby declared to be a non-residential work centre, to be known as the High Street Work Centre, for males aged at the time of sentence not less than 15 years.

7. Constitution of Toroa Street Work Centre—The land described in the Sixth Schedule to this notice is hereby declared to be a non-residential work centre, to be known as the Toroa Street Work Centre, for males and females aged at the time of sentence not less than 15 years.

8. Closure of Stuart Street Work Centre—(1) The land described in the Seventh Schedule to this notice, which was declared to be a work centre by clause 2 (10) of the Work Centres Notice 1975*, is hereby declared to be no longer a work centre.

(2) The Work Centres Notice 1975* is hereby amended—

(a) By revoking clause 2 (10):

(b) By revoking so much of the First Schedule as relates to the land tenthly described in that Schedule.

9. Revocations—(1) Clauses 2 to 6 of this notice are given in substitution for the Work Centre Notice (No. 2) 1981†, which is hereby revoked.

(2) Clause 8 of this notice is given in substitution for the Work Centre (Stuart Street) Closure Notice 1981‡, which is hereby revoked.

SCHEDULES

Clause 2

FIRST SCHEDULE

All that parcel of land in the Westland Land District, containing 70 square metres, more or less, being part Section 4, Borough of Greymouth, in Block XII, Greymouth Survey District; and being also Lot 38 on plan D.E. 22039 (formerly Lot 14 on plan L.O. 11454) deposited in the office of the Minister of Railways.

Clause 3

SECOND SCHEDULE

All that parcel of land in the Wellington Land District, containing 627 square metres, more or less, being Lot 9 on Deposited Plan 28401, situate in Block I, Rimutaka Survey District, and being all the land comprised and described in certificate of title, Volume F4, folio 1473, Wellington Registry.

THIRD SCHEDULE

All that parcel of land in the Marlborough Land District, containing 382 square metres, more or less, situate in the Borough of Blenheim, being Lot 1 on Deposited Plan 4206, and being all the land comprised and described in certificate of title, Volume 2B, folio 1084, Marlborough Registry.

FOURTH SCHEDULE

Clause 5

All that parcel of land in the North Auckland Land District, being part Section 16, Block XVI, Kawakawa Survey District; as the same is more particularly delineated on the plan marked LEG. 28-2-2, held in the Head Office of the Department of Justice, and thereon edged in green.

FIFTH SCHEDULE

Clause 6

All that parcel of land in the Canterbury Land District, containing 986 square metres, more or less, being Section 67, Town of Timaru, and being all the land comprised and described in certificate of title, Volume 20B, folio 1191, Canterbury Registry.

SIXTH SCHEDULE

Clause 7

All that parcel of land in the South Auckland Land District, containing 350 square metres, more or less, being part Section 43, Town of Whakatane, Block II, Whakatane Survey District; as the same is more particularly delineated on S.O. Plan 43774 held in the Head Office of the Department of Justice and thereon edged in red.

SEVENTH SCHEDULE

Clause 8

All that parcel of land in the Otago Land District, containing 21.3 perches, more or less, being part of Sections 40 and 44, Block XIII, Town of Dunedin, and being the whole of the land comprised and described in certificate of title, Volume 287, folio 15, Otago Registry; and also all that parcel of land in the Otago Land District, containing 1 rood 0.02 perches, more or less, being Section 39, Block XII, Town District (Deposited Plan 3985), and being the whole of the land comprised and described in certificate of title, Volume 240, folio 37, Otago Registry.
