

THE WORK CENTRES NOTICE 1983

PURSUANT to section 4 of the Criminal Justice Amendment Act 1962, the Minister of Justice hereby gives the following notice.

NOTICE

- 1. Title and commencement—(1) This notice may be cited as the Work Centres Notice 1983.
 - (2) This notice shall take effect from the 16th day of September 1983.
- **2. Constitution of work centres**—(1) The land first described in the Schedule to this notice is hereby declared to be a non-residential work centre, to be known as the Poto Avenue Work Centre for males and females aged at the time of sentence not less than 15 years.
- (2) The land secondly described in the Schedule to this notice is hereby declared to be a non-residential work centre, to be known as the Wilson Street Work Centre, for males and females aged at the time of sentence not less than 15 years.
- (3) The land thirdly described in the Schedule to this notice is hereby declared to be a non-residential work centre, to be known as the Taniwha Street Work Centre, for males and females aged at the time of sentence not less than 15 years.
- (4) The land fourthly described in the Schedule to this notice is hereby declared to be a non-residential work centre, to be known as the Wakefield Street Work Centre for males and females aged at the time of sentence not less than 15 years.
- **3. Revocations**—(1) The Work Centre (Taniwha Street) Notice 1977* and the Work Centre (Wakefield Street) Notice 1983† are hereby revoked.
 - (2) The Work Centres Notice 1975‡ is hereby amended—
 - (a) By revoking subclauses (30) and (34) of clause 2:
 - (b) By revoking so much of the First Schedule as relates to the land thirtiethly and thirty-fourthly described in that Schedule.

FIRST, all that parcel of land in the North Auckland Land District, containing 1112 square metres, more or less, situated in the City of Whangarei, being Lots 30 and 31 on Deposited Plant 13841, being part Allotment 1, Whangarei Parish, situated in Block XII, Purua Survey District, and being the whole of the land comprised and described in certificate of title, Volume 394, folio 257, North Auckland Registry.

Secondly, all that parcel of land in the Wellington Land District, containing 1 rood, more or less, situated in the City of Wanganui, being Section 255, Town of Wanganui, and being the whole of the land comprised and described in certificate of title, Volume 331, folio 101, Wellington Land

Registry, limited as to parcels.

Thirdly, all that parcel of land in the South Auckland Land District, containing 1113 square metres, more or less, being Section 1, Block XI, Town of Taupo, and being the whole of the land comprised and described in certificate of title, Volume 721, folio 287, South Auckland Registry.

Fourthly, all that parcel of land in the Hawke's Bay Land District containing 1013 square metres, more or less, situated in the City of Napier, being Lot 3 on Deposited Plan 14745, and being the whole of the land comprised and described in certificate of title, Volume G3, folio 255, Hawke's Bay Registry.
