THE WORK CENTRES NOTICE (NO. 2) 1984

PURSUANT to section 4 of the Criminal Justice Amendment Act 1962, the Minister of Justice hereby gives the following notice.

NOTICE

- 1. Title and commencement—(1) This notice may be cited as the Work Centres Notice (No. 2) 1984.
 - (2) This notice shall take effect from the 1st day of October 1984.
- 2. Constitution of work centres—(1) The land first described in the Schedule to this notice is hereby declared to be a non-residential work centre, to be known as the Alfred Street Work Centre, for males and females aged at the time of sentence not less than 15 years.

(2) The land secondly described in the Schedule to this notice is hereby declared to be a non-residential work centre, to be known as the Johnston Street Work Centre, for males and females aged at the time of sentence not less than 15 years.

(3) The land thirdly described in the Schedule to this notice is hereby declared to be a non-residential work centre, to be known as the Porchester Road Work Centre, for males and females aged at the time of sentence not less than 15 years.

(4) The land fourthly described in the Schedule to this notice is hereby declared to be a non-residential work centre, to be known as the Dixon Street Work Centre, for males and females aged at the time of sentence

not less than 15 years.

- (5) The land fifthly described in the Schedule to this notice is hereby declared to be a non-residential work centre, to be known as the Hinemoa Street Work Centre, for males and females aged at the time of sentence not less than 15 years.

Alfred Street Work Centre
