

THE WORK CENTRES NOTICE (NO. 2) 1988

PURSUANT to section 126 (1) of the Criminal Justice Act 1985, the Minister of Justice hereby gives the following notice.

NOTICE

- 1. Title and commencement—(1) This notice may be cited as the Work Centres Notice (No. 2) 1988.
 - (2) This notice shall take effect from the 1st day of August 1988.
- 2. Constitution of Ashburton Work Centre—The land described in the First Schedule to this notice is hereby declared to be a work centre, to be known as the Ashburton Work Centre.
- **3. Constitution of Rangiora Work Centre**—The land described in the Second Schedule to this notice is hereby declared to be a work centre, to be known as the Rangiora Work Centre.
- **4. Constitution of Taumarunui Work Centre**—The land described in the Third Schedule to this notice is hereby declared to be a work centre, to be known as the Taumarunui Work Centre.

FIRST SCHEDULE ASHBURTON WORK CENTRE

All that parcel of land in the Canterbury Land District containing 483 square metres, more or less, situated in the Borough of Ashburton, being Lot 3 on Deposited Plan 18133, and being the whole of the land comprised and described in certificate of title, Volume 14A, folio 1149, Canterbury Registry.
