

THE WORK CENTRES NOTICE (NO. 4) 1984

PURSUANT to section 4 of the Criminal Justice Amendment Act 1962, the Minister of Justice gives the following notice.

NOTICE

1. Title and commencement—(1) This notice may be cited as the Work Centres Notice (No. 4) 1984.

(2) This notice shall take effect from the 1st day of January 1985.

2. Constitution of work centres—(1) The land first described in the Schedule to this notice is hereby declared to be a non-residential work centre, to be known as the Hutt Road Work Centre, for males and females aged at the time of sentence not less than 15 years.

(2) The land secondly described in the Schedule to this notice is hereby declared to be a non-residential work centre, to be known as the David Street Work Centre, for males and females aged at the time of sentence

not less than 15 years.

- (3) The land thirdly described in the Schedule to this notice is hereby declared to be a non-residential work centre, to be known as the Henderson Work Centre, for males and females aged at the time of sentence not less than 15 years.
- **3. Amendments and revocation**—(1) The Work Centres Notice 1975* is hereby amended—

(a) By revoking subclauses (18) and (25) of clause 2:

- (b) By revoking so much of the First Schedule as relates to the land eighteenthly, and the land twenty-fifthly, described in that Schedule.
- (2) The Work Centre (Henderson) Notice 1981† is hereby revoked.

SCHEDULE

Hutt Road Work Centre

ALL that parcel of land in the Wellington Land District, containing 1952 square metres, more or less, situated in Block XIII, Belmont Survey District, Borough of Petone, and being parts 19B, 19C, 19D, 19D1, and 19D2 of Section 3, Hutt District; as the same is more particularly delineated on the plan M.O.W. 27346 (S.O. Plan 28557) deposited in the office of the Minister of Works at Wellington and thereon coloured orange.

David Street Work Centre

ALL that parcel of land in the Wellington Land District, containing 31 perches, more or less, situated in the City of Palmerston North, being part Section 338, Public Map Township of Palmerston North, and being the whole of the land comprised and described in certificates of title, Volume 56, folio 173, and Volume 99, folio 82, Wellington Registry.

Henderson Work Centre

ALL that parcel of land in the Auckland Land District, containing 857 square metres, more or less, being part Allotment 161, Parish of Waikomiti, and being also Lot 1 on Deposited Plan 39597, and being the whole of the land comprised and described in certificate of title, Volume 1052, folio 253, Auckland Registry.
