



THE WORK CENTRES NOTICE (NO. 3) 1984

PURSUANT to section 4 of the Criminal Justice Amendment Act 1962, the Minister of Justice hereby gives the following notice.

NOTICE

1. Title and commencement—(1) This notice may be cited as the Work Centres Notice (No. 3) 1984.

(2) This notice shall take effect from the 1st day of December 1984.

2. Constitution of work centres—(1) The land first described in the Schedule to this notice is hereby declared to be a non-residential work centre, to be known as the High Street Work Centre, for males and females aged at the time of sentence not less than 15 years.

(2) The land secondly described in the Schedule to this notice is hereby declared to be a non-residential work centre, to be known as the Disraeli Street Work Centre, for males and females aged at the time of sentence not less than 15 years.

(3) The land thirdly described in the Schedule to this notice is hereby declared to be a non-residential work centre, to be known as the Percy Street Work Centre, for males and females aged at the time of sentence not less than 15 years.

(4) The land fourthly described in the Schedule to this notice is hereby declared to be a non-residential work centre, to be known as the Halstead Street Work Centre, for males and females aged at the time of sentence not less than 15 years.

(5) The land fifthly described in the Schedule to this notice is hereby declared to be a non-residential work centre, to be known as the Brisbane Street Work Centre, for males and females aged at the time of sentence not less than 15 years.

(6) The land sixthly described in the Schedule to this notice is hereby declared to be a non-residential work centre, to be known as the Hill Street Work Centre, for males and females aged at the time of sentence not less than 15 years.

(7) The land seventhly described in the Schedule to this notice is hereby declared to be a non-residential work centre, to be known as the Queen Street Work Centre, for males and females aged at the time of sentence not less than 15 years.

(8) The land eighthly described in the Schedule to this notice is hereby declared to be a non-residential work centre, to be known as the Wood Street Work Centre, for males and females aged at the time of sentence not less than 15 years.

3. Revocation and amendments—(1) The Work Centre (Percy Street) Notice 1978* is hereby revoked.

(2) The Work Centres Notice 1975† is hereby amended—

(a) By revoking subclauses (8), (15), and (21) of clause 2:

(b) By revoking so much of the Schedule as relates to the land eighthly, fifteenthly, and twenty-firstly described in that Schedule.

(3) The Work Centres Notice (No. 2) 1976‡ is hereby amended—

(a) By revoking clause 5:

(b) By revoking so much of the Schedule as relates to the land fourthly described in that Schedule.

(4) The Work Centres Notice 1982§ is hereby amended—

SCHEDULE

HIGH STREET WORK CENTRE

All that parcel of land in the Canterbury Land District, containing 986 square metres, more or less, being Section 67, Town of Timaru, and being the whole of the land comprised and described in certificate of title, Volume 20B, folio 1191, Canterbury Registry.

DISRAELI STREET WORK CENTRE

All that parcel of land in the Gisborne Land District, containing 14.8 perches, more or less, being Lot 2 on Deposited Plan 2501, and being the whole of the land comprised and described in certificate of title, Volume 2D, folio 1385, Gisborne Registry.

PERCY STREET WORK CENTRE

All that parcel of land in the Otago Land District, containing 1334 square metres, more or less, being part Lots 17 and 18 on Deposited Plan 1061, part Lot 3 and Lot 4 on Deposited Plan 3921, and part Lots 1 and 2 on Deposited Plan 5130, and being part Section 12, Block VII, Town District, and being the whole of the land comprised and described in certificate of title, Volume 3B, folio 185, Otago Registry.

HALSTEAD STREET WORK CENTRE

All that parcel of land in the Nelson Land District, containing 18.3 perches, more or less, situated in the City of Nelson, being part Sections 217 and 219, City of Nelson, and being the whole of the land comprised and described in certificate of title, Volume 2B, folio 795, Nelson Registry.

BRISBANE STREET WORK CENTRE

- (c) Containing 195 square metres, more or less, being part Allotment 11, as shown marked "A" on S.O. Plan 53388;—

as the same are more particularly delineated on the plan marked ADM 13-3-79-1 held in the Head Office of the Department of Justice and thereon edged in red.

WOOD STREET WORK CENTRE

All that parcel of land in the South Auckland Land District, containing 552 square metres, more or less, being part Sections 32, 33, 38, and 39, Block VI, Town of Paeroa, and Block XIII, Ohinemuri Survey District, and marked "B" on S.O. Plan 53482; as the same is more particularly delineated on the plan marked ADM 13-9-54-1 held in the Head Office of the Department of Justice and thereon marked in red.
