

THE WORKERS' COMPENSATION ORDER 1969, AMENDMENT NO. 6

PURSUANT to section 38 of the Workers' Compensation Act 1956, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

1. Title and commencement—(1) This order may be cited as the Workers' Compensation Order 1969, Amendment No. 6, and shall be read together with and deemed part of the Workers' Compensation Order 1969* (hereinafter referred to as the principal order).

(2) This order shall come into force on the 7th day after the date

of its notification in the Gazette.

2. Medical expenses—Clause 8 of the principal order (as substituted by clause 2 of the Workers' Compensation Order 1969, Amendment No. 1, and amended by clause 4 of the Workers' Compensation Order 1969, Amendment No. 2, and by clause 2 of the Workers' Compensation Order 1969, Amendment No. 5) is hereby further amended—

(a) By omitting from subclause (1) (a) the expression "\$3.75", and

substituting the expression "\$6.00":

- (b) By omitting from subclause (1) (a) the expression "\$2.50", and substituting the expression "\$4.50":
- (c) By omitting from subclause (1) (b) the words "there shall be payable an additional amount of \$1.00", and substituting the words "the maximum under paragraph (a) of this subclause shall be increased by \$3.00":

"(c) For each attendance to a patient, there shall be payable a medical travel fee of a maximum of \$0.35 for each mile travelled in respect of that attendance:".

EXPLANATORY NOTE

This note is not part of the order, but is intended to indicate its general effect. This order increases the maximum amounts payable to medical practitioners in respect of attendances for the purpose of the Workers' Compensation Act 1956. In the case of first attendances the maximum is increased to \$6.00, and for subsequent attendances to \$4.50.

Where the attendance takes place on a Saturday, Sunday, or public holiday, or between 6 p.m. and 8 a.m. Monday to Friday, these maximums are increased

by an additional \$3.00.

The medical travel fee remains unchanged at \$0.35 for each mile travelled, but the requirement that the fee could be claimed only for each mile travelled after the first 4 miles has been revoked.
