THE WRECK DISTRICTS NOTICE 1969

PURSUANT to section 342 of the Shipping and Seamen Act 1952, the Minister of Marine hereby gives the following notice.

NOTICE

1. Title and commencement—(1) This notice may be cited as the Wreck Districts Notice 1969.

(2) This notice shall come into force on the 1st day of October 1969.

2. Wreck districts—(1) The districts specified in the Schedule to this notice are hereby established as wreck districts for the purposes of Part IX of the Shipping and Seamen Act 1952.

(2) For the purposes of this notice, every wreck district shall include—

(a) All cities, boroughs, and town districts that are within the outer boundaries of any county included in that wreck district or are bounded by any such county or are between any such county and the sea:

(b) All islands that are adjacent to that wreck district and do not form part of the district of any local authority:

(c) The waters of the territorial sea of New Zealand that are adjacent to that wreck district.

(3) If any question arises as to the wreck district in which any island that does not form part of the district of any local authority is included or as to the wreck district in which any part of the territorial sea of New Zealand is included, that question shall be determined by the Secretary for Marine.

3. Receivers of Wreck—The persons for the time being holding the offices specified in the third column of the Schedule to this notice are hereby appointed to be Receivers of Wreck and are hereby assigned to the respective wreck districts specified in the first column of that Schedule.

4. **Revocation**—The notice by the Minister in charge of the Marine Department dated the 9th day of September 1881 appointing districts and Receivers of Wreck* is hereby revoked.
