**THE WHITEBAIT FISHING REGULATIONS 1964,
AMENDMENT NO. 6**

ORDER IN COUNCIL

At the Government Buildings at Wellington this 8th day of February 1971

THE RIGHT HON. J. R. MARSHALL PRESIDING IN COUNCIL

PURSUANT to the Fisheries Act 1908, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Whitebait Fishing Regulations 1964, Amendment No. 6, and shall be read together with and deemed part of the Whitebait Fishing Regulations 1964* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the seventh day after the date of their notification in the *Gazette*.

2. Use of screens—(1) Regulation 26 of the principal regulations is hereby amended by inserting, after subclause (1), the following subclause:

“(1A) Notwithstanding anything to the contrary in subclause (1) of this regulation, 2 or more screens may be used at a site registered under regulation 32 of these regulations so long as they are placed only in each of the spaces between the nets authorised to be used from the site and the water’s edge.”

(2) The said regulation 26 is hereby consequentially further amended—

(a) By omitting from paragraph (c) of subclause (1) (as substituted by regulation 4 of the Whitebait Fishing Regulations 1964, Amendment No. 1) the words “in the case of a screen”, and substituting the words “in the case of screens”:

- (b) By omitting from paragraph (d) of subclause (1) the words "sunset", and substituting the words "8 o'clock in the evening":
- (c) By inserting in subclause (2), after the word "screen", the words "or screens".

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations are intended to regularise the practice of permitting screens to be used between the multiple nets permitted to be used from sites registered under regulation 32 of the principal regulations and between the innermost net and the water's edge. The combined length of the screens and the nets is not to extend more than one-third of the way across the river, stream, or channel where the fishing is taking place.
