ORDER IN COUNCIL

At the Government House at Wellington this 21st day of July 1975

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

Pursuant to the Fisheries Act 1908, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Whitebait Fishing Regulations 1964, Amendment No. 7, and shall be read together with and deemed part of the Whitebait Fishing Regulations 1964* (hereinafter referred to as the principal regulations).
- (2) These regulations shall come into force on the day after the date of their notification in the Gazette.
- 2. Metric amendments—The principal regulations are hereby amended in the manner indicated in the Schedule to these regulations.

METRIC AMENDMENTS TO WHITEBAIT FISHING REGULATIONS 1964

3 (c)	By omitting the words "500 yards", and substituting the expression "500 m".
9 (as amended by regulation 3 of the Whitebait Fishing Regulations 1964, Amendment No. 2), 10, 19, 32 (n)	By omitting the words "1 chain" wherever they occur, and substituting in each case the expression "20 m".
12	By omitting the expression "15 ft", and substituting the expression "4.5 m".
13 (2) (b) (as substituted by regulation 4 of the Whitebait Fishing Regulations 1964, Amendment No. 2), 21	By omitting the words "10 yards" wherever they occur, and substituting in each case the expression "10 m".
18, 26 (1), 35 (k)	By omitting the expression "20 ft" wherever it occurs, and substituting in each case the expression "6 m".
26 (1) (c) (as substituted by regulation 4 of the Whitebait Fishing Regulations 1964, Amendment No. 1), 35 (g)	By omitting the expression "10 ft" and substituting the expression "3 m".
35 (j), 36	By omitting the words "2 chains", and substituting the expression "40 m".
Second Schedule	By omitting the words "1 chain" wherever they occur, and substituting in each case the expression "20 m".

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations amend the Whitebait Fishing Regulations 1964 and their amendments by making metric conversions.
