

THE WAGE FREEZE REGULATIONS 1982, AMENDMENT NO. 21

ORDER IN COUNCIL

At the Government Buildings at Wellington this 7th day of February 1984

PURSUANT to the Economic Stabilisation Act 1948, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. Title—These regulations may be cited as the Wage Freeze Regulations 1982, Amendment No. 21, and shall be read together with and deemed part of the Wage Freeze Regulations 1982* (hereinafter referred to as the principal regulations).
- 2. Commencement and expiry—(1) These regulations shall come into force on the 8th day of February 1984.
- (2) These regulations shall continue in force until the close of the 29th day of February 1984, and shall then expire.
- 3. Fourth Schedule amended—The Fourth Schedule to the principal regulations (as added by regulation 9 of the Wage Freeze Regulations 1982, Amendment No. 2) is hereby amended by adding, after clause 91 (as added by regulation 8 (4) of the Wage Freeze Regulations 1982, Amendment No. 19), the following clause:

"92. An instrument or instruments entered into with the Auckland Harbour Board to prescribe Sunday work provisions for waterside workers, tally clerks, harbour board employees, and foremen stevedores employed at the Auckland container terminal, these provisions to vary partially the Sunday work provisions contained in principal orders numbers 476 dated 21 April 1982, FS 14 dated 23 March 1981, and TC 17 dated 11 November 1980 and which were made by the Waterfront Industry Tribunal."

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 8 February 1984, vary the wage freeze, which continues until the close of 29 February 1984.

Regulation 3 provides for a further exemption under regulation 6A of the principal regulations. To be exempt under that regulation an instrument must implement a complete settlement and be an instrument which—

- (a) Is made after the commencement of the principal regulations on 23 June 1982; and (b) Is specified in the Fourth Schedule to the principal regulations (as amended by these
- regulations); and

 (c) Contains terms relating to remuneration, or to both remuneration and reimbursing payments, all of which, after having been referred to the Wage Freeze Authority on the application of the parties, or, if there are not two or more parties, on the application of the employer, have been approved by it.
