

THE WAGE FREEZE REGULATIONS 1982, AMENDMENT NO. 28

ORDER IN COUNCIL

At the Government Buildings at Wellington this 5th day of March 1984

PURSUANT to the Economic Stabilisation Act 1948, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Wage Freeze Regulations 1982, Amendment No. 23, and shall be read together with and deemed part of the Wage Freeze Regulations 1982* (hereinafter referred to as the principal regulations).
 - (2) These regulations shall come into force on the 6th day of March 1984.
- 2. Exemptions in respect of Government employees employed outside New Zealand—The principal regulations are hereby amended by inserting, after regulation 6AB (as inserted by regulation 3 of the Wage Freeze Regulations 1982, Amendment No. 19), the following regulation:

Nothing in regulation 5 or regulation 5A of these regulations applies in respect of any instrument which is made after the commencement of these regulations and which increases any rate of remuneration of any person or the amount of any reimbursing payment payable to any person if—

"(a) The person is—

"(i) A person employed in the overseas service (within the meaning of the Foreign Affairs and Overseas Service Act 1983); or

"(ii) A serviceman (within the meaning of section 2 (1) of the Defence Act 1971); or

"(iii) An expert appointed by the Ministry of Foreign Affairs; or

"(iv) A State employee working or serving outside New Zealand; or

"(v) A State employee who is outside New Zealand either under an exchange scheme or for the purposes of carrying out study, training, or research; and

"(b) The remuneration or reimbursing payment is in respect of the person's employment or duties outside New Zealand; and

"(c) All the increases effected by the instrument are increases arising from factors external to the economy of New Zealand."

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 6 March 1984, vary the wage freeze.

The effect of the regulations is to exempt from the wage freeze instruments that effect increases in the rates of remuneration of, or the amounts of the reimbursing payments payable to, certain classes of Government employees who carry out their duties outside New Zealand.

The exemption applies only where the increase arises from factors external to the economy of New Zealand.
