PURSUANT to the Economic Stabilisation Act 1948, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Wage Freeze Regulations 1982, Amendment No. 29, and shall be read together with and deemed part of the Wage Freeze Regulations 1982* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 26th day of June 1984.

2. Fourth Schedule amended—The Fourth Schedule to the principal regulations (as added by regulation 9 of the Wage Freeze Regulations 1982, Amendment No. 2) is hereby amended by adding, after clause 121 (as added by regulation 3 of the Wage Freeze Regulations 1982, Amendment No. 28), the following clauses:

*S.R. 1982/141 (Reprinted with Amendments Nos. 1 to 28: S.R. 1984/156)

"122. An instrument or instruments entered into with Joint Venture Züblin Williamson and any subcontractors to Joint Venture Züblin Williamson to prescribe conditions of employment for work carried out by catering and domestic staff at the Bannockburn Camp accommodation facility in Cromwell.

"123. An instrument entered into with the Wellington City Council (Municipal Electricity Department) to prescribe an allowance for electrical workers employed inside the roof space and ventilation shafts of the Mount Victoria tunnel on the installation of pilot cables and associated motor protection equipment for the fan ventilation system.

"124. An instrument or instruments entered into with Avon Cosmetics Limited to prescribe relocation payments for staff transferred from Pakuranga and Papatoetoe to Springs Road, East Tamaki.

"125. An instrument entered into with Samuel Parker Limited to prescribe relocation payments for staff transferring from Newmarket to Penrose."

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 26 June 1984, vary the wage freeze.

Regulation 2 provides for further exemptions under regulation 6A of the principal regulations. To be exempt under that regulation an instrument must implement a complete settlement and be an instrument which—

- (a) Is made after the commencement of the principal regulations on 23 June 1982; and
- (b) Is specified in the Fourth Schedule to the principal regulations (as amended by these regulations); and
- (c) Contains terms relating to remuneration, or to both remuneration and reimbursing payments, all of which, after having been referred to the Wage Freeze Authority on the application of the parties, or, if there are not two or more parties, on the application of the employer, have been approved by it.
